### EXPLANATORY NOTE


#### (This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Law Reform Commission (Amendment) Bill, 1984.

The object of this Bill is to provide a defence in civil proceedings for defamation in respect of—

- (a) the publication, by the Minister or the Law Reform Commission ("the Commission"), of interim or final reports of the Commission prior to their tabling in Parliament (Schedule 1 (1));
- (b) a publication in the course of the proceedings of, or of an inquiry held by, the Commission or any other publication by the Commission in connection with a reference (Schedule 1 (1)); and
- (c) the publication of fair reports of public proceedings of, or public inquiries held by, the Commission (Schedule 1 (2)).

# A BILL FOR

An Act to amend the Defamation Act, 1974, to provide, in civil proceedings for defamation, defences in respect of reports, inquiries and proceedings of the Law Reform Commission.

### Defamation (Law Reform Commission) Amendment 1984

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

### 5 Short title.

1. This Act may be cited as the "Defamation (Law Reform Commission) Amendment Act, 1984".

### Amendment of Act No. 18, 1974.

2. The Defamation Act, 1974, is amended in the manner set forth in 10 Schedule 1.




