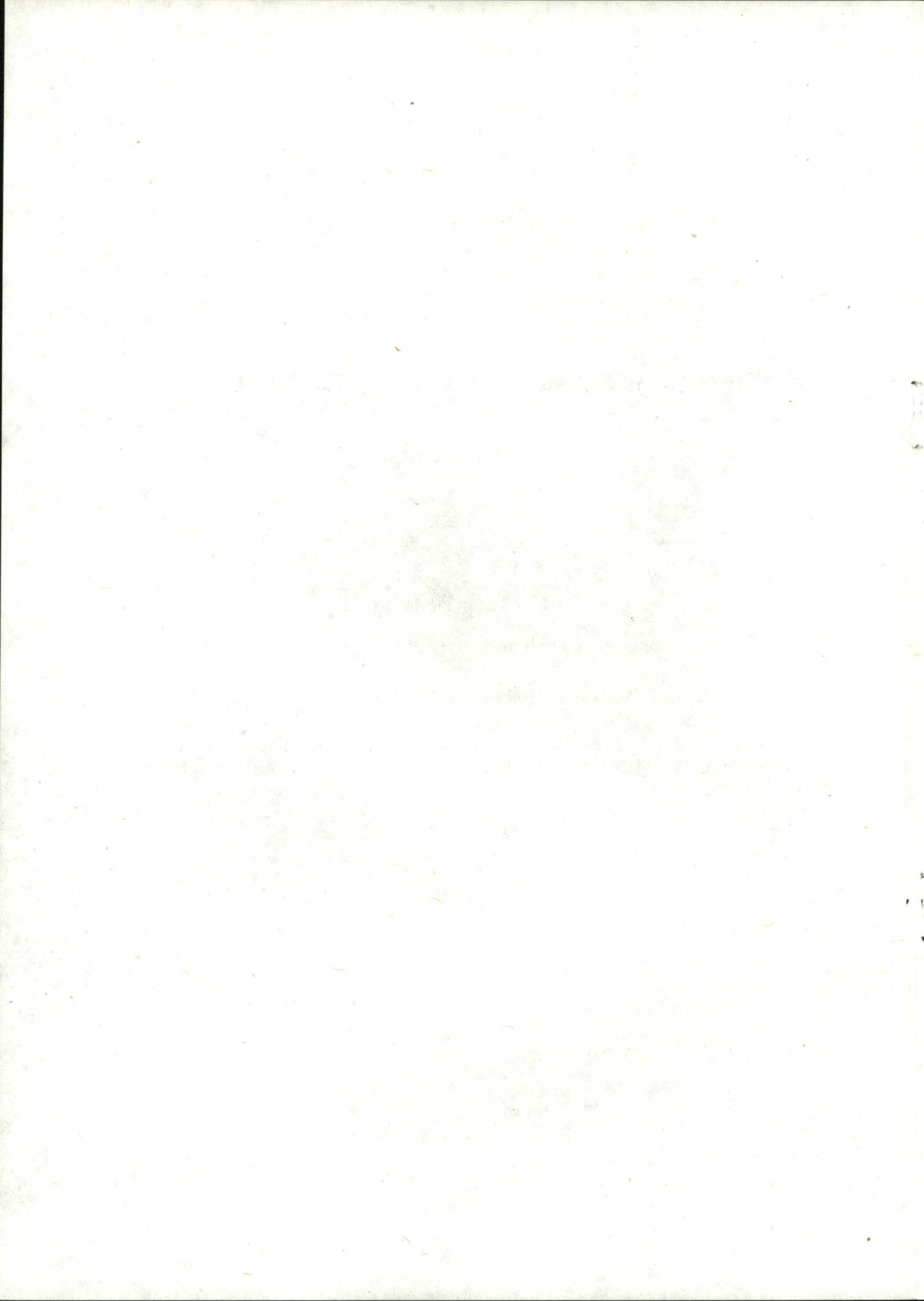


EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Human Tissue (Amendment) Bill 1987.

The object of this Bill is to amend section 11 of the Drug Misuse and Trafficking Act 1985 so that the offence of being in possession of any item of equipment for use in the administration of a prohibited drug does not apply to a hypodermic syringe or hypodermic needle.



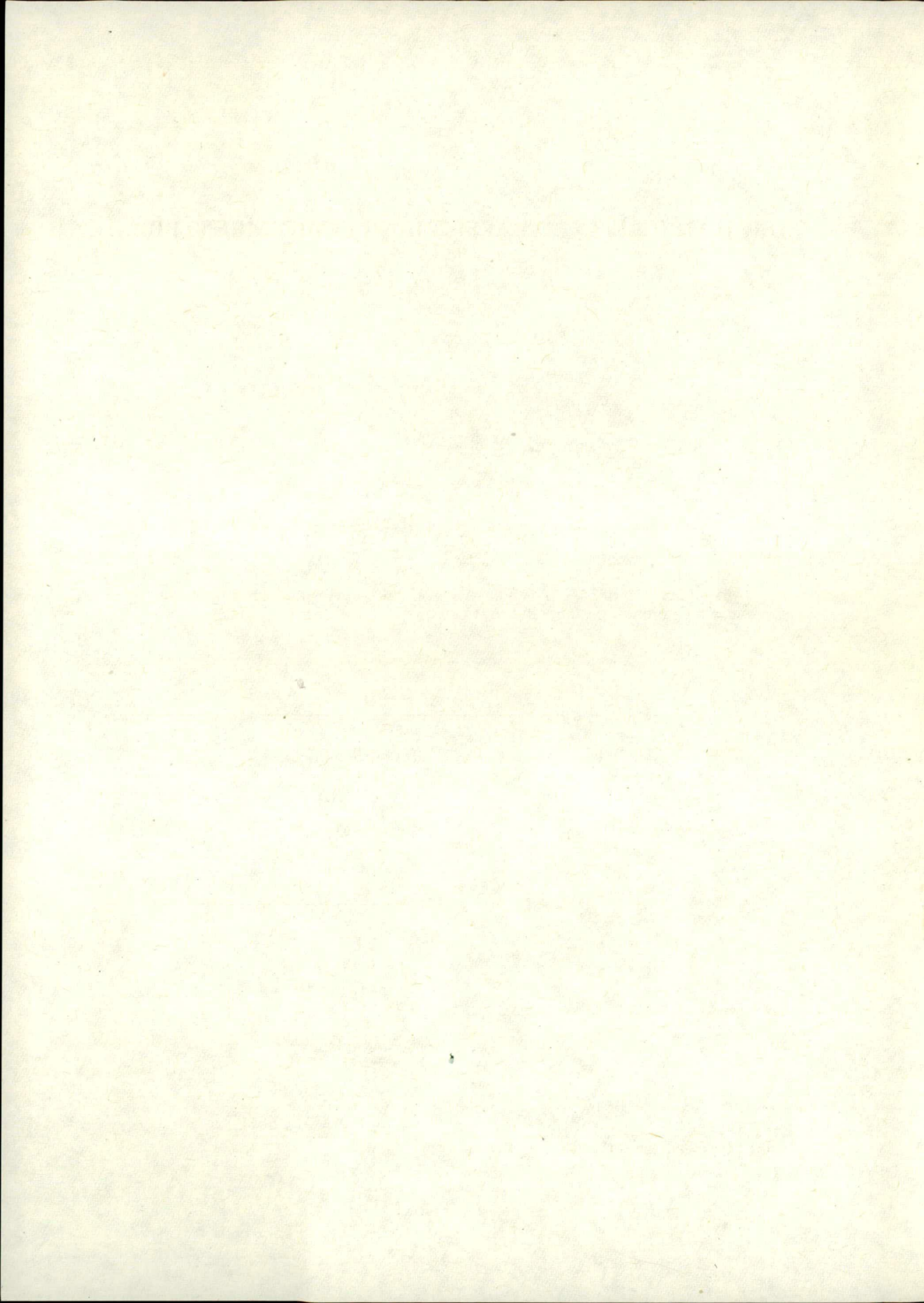

An Act to amend the Drug Misuse and Trafficking Act 1985 with respect to the possession of certain items of equipment.

Drug Misuse and Trafficking (Amendment) 1987

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

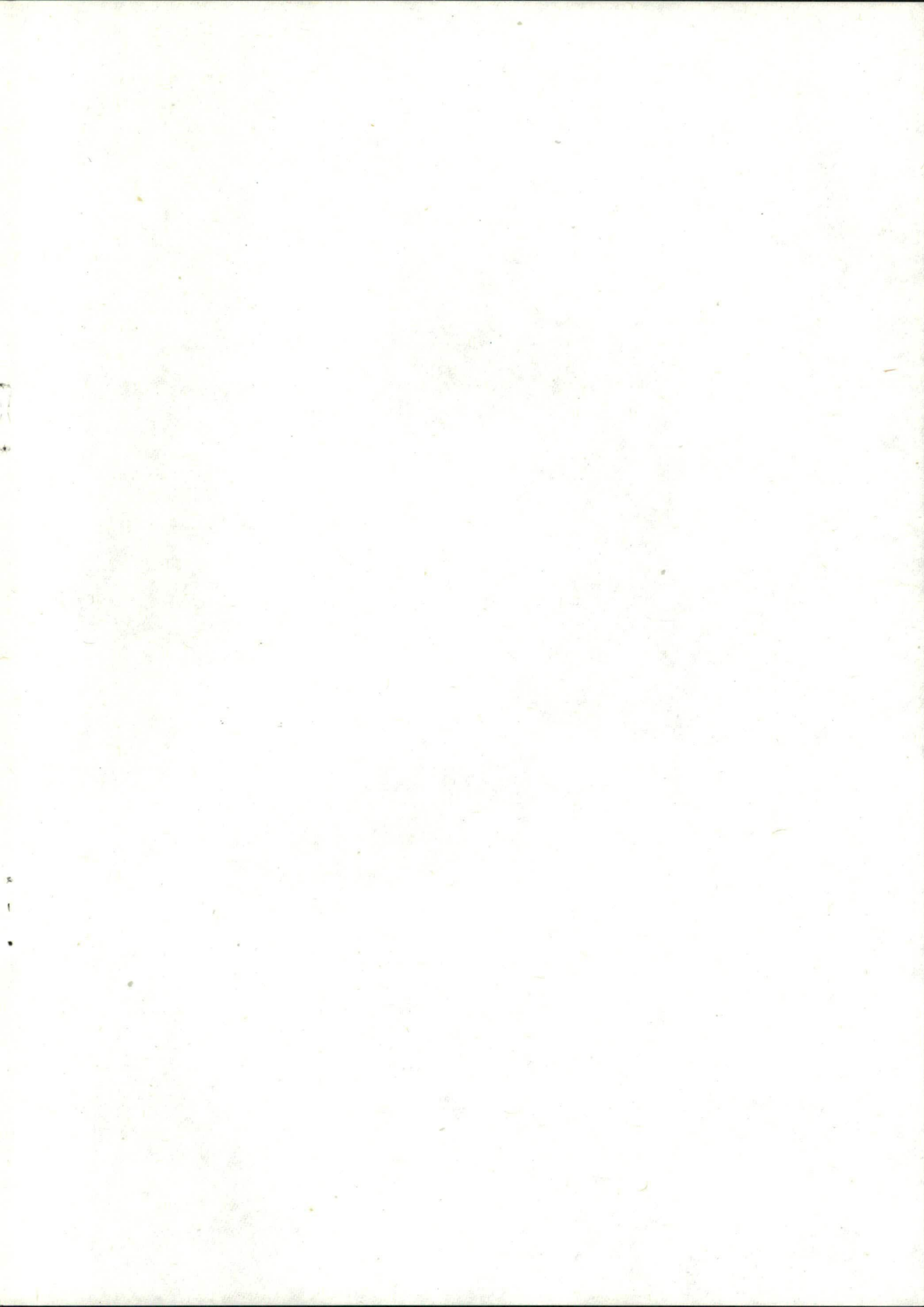

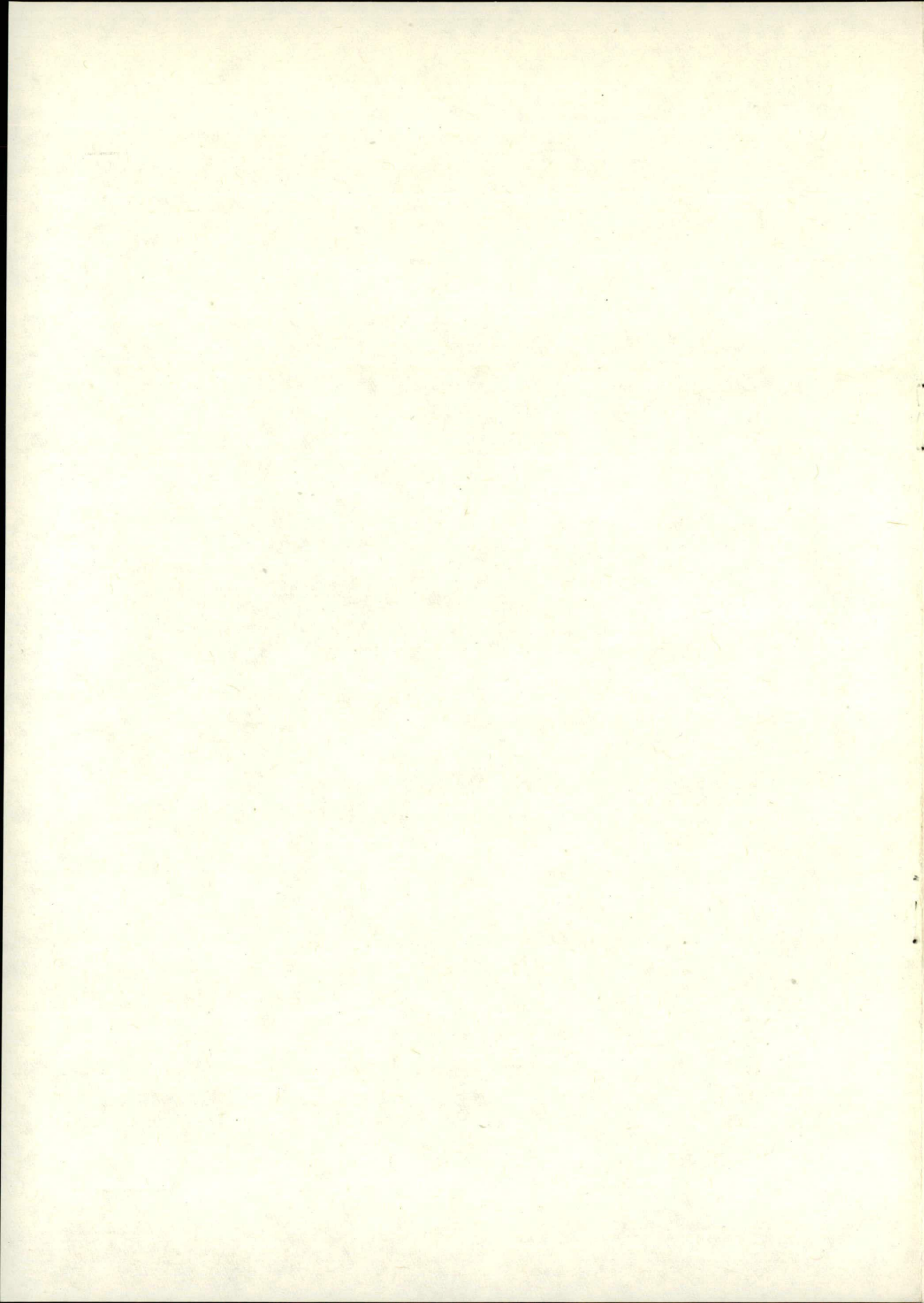
1. This Act may be cited as the "Drug Misuse and Trafficking (Amendment) Act 1987".

An Act to amend the Drug Misuse and Trafficking Act 1985 with respect to the possession of certain items of equipment. [Assented to 16 June 1987]

Drug Misuse and Trafficking (Amendment) 1987

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

Short title

1. This Act may be cited as the "Drug Misuse and Trafficking (Amendment) Act 1987".
