**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

**5 Short title**

**1.** This Act may be cited as the "Education Commission (Amendment) Act 1985".

**Amendment of Act No. 23, 1980**

**2.** The Education Commission Act 1980 is amended by inserting after  
10 Division 3 of Part III the following Division:

**DIVISION 4—*Temporary appointments***

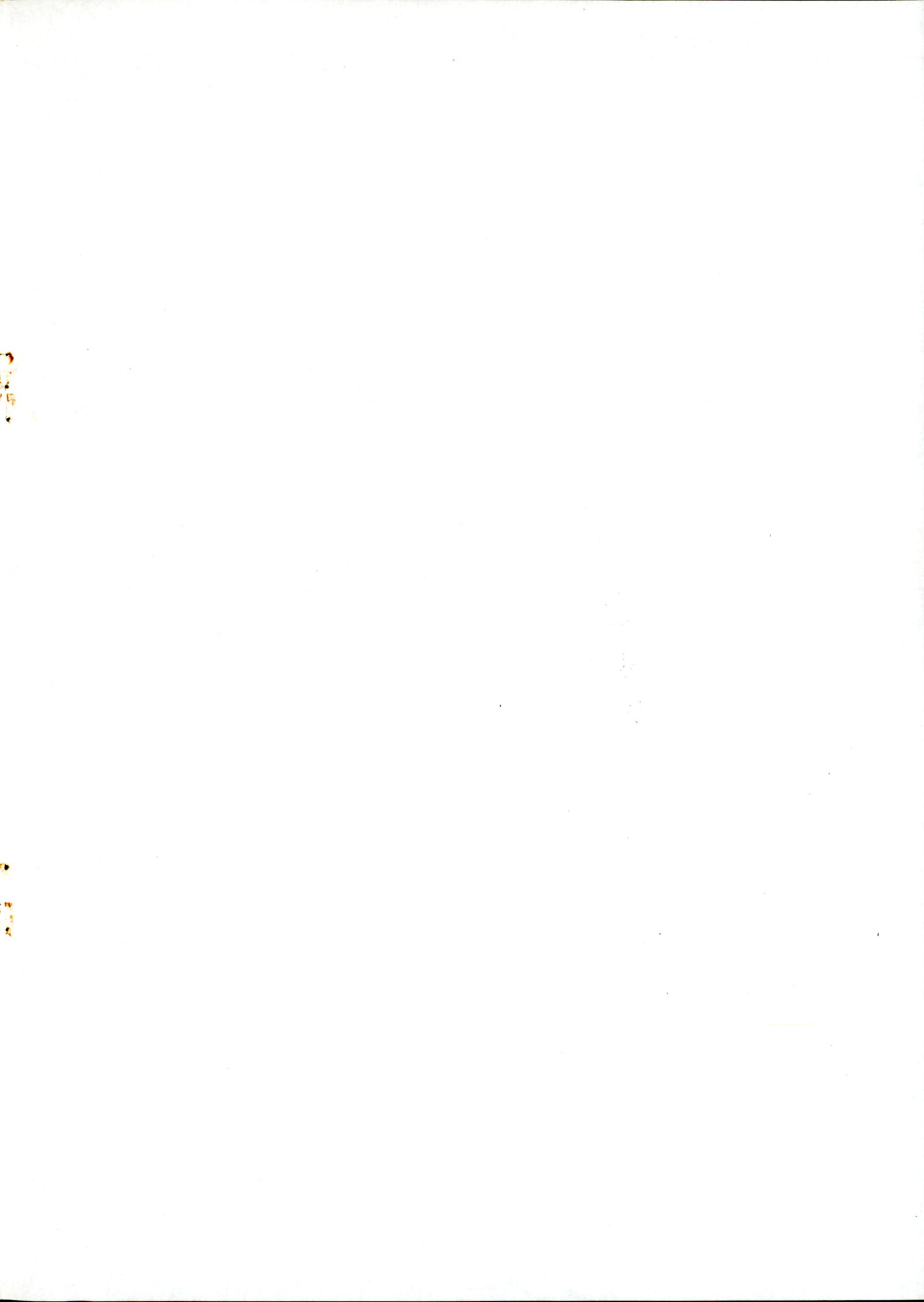

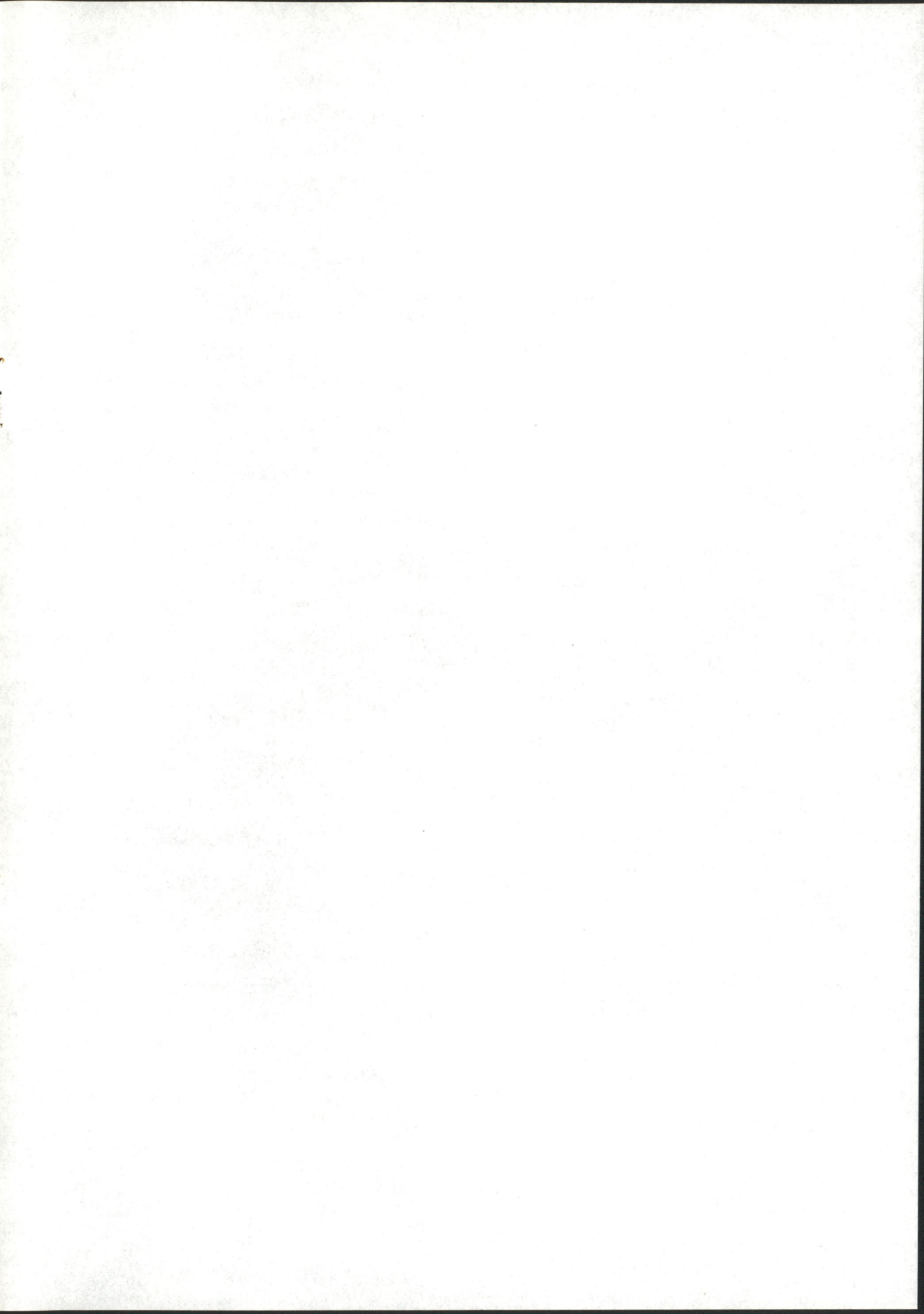

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

**Short title**

1. This Act may be cited as the "Education Commission (Amendment) Act 1985".
