**EDUCATION COMMISSION (FURTHER AMENDMENT)

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Chifley University Interim Council Bill 1987.

The object of this Bill is to amend section 13 of the Education Commission Act 1980 so as to enable an Acting Chairman of the Education Commission to be appointed to act either as a full-time or as a part-time member of the Commission.

Clause 1 specifies the short title of the proposed Act.

Clause 2 amends the Education Commission Act 1980 for the purpose described above.

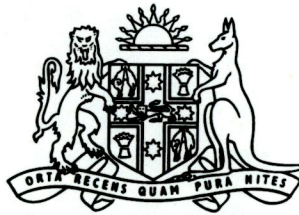

A BILL FOR

An Act to amend the Education Commission Act 1980 so as to enable an Acting Chairman of the Education Commission to be appointed to act either as a full-time or as a part-time member of the Commission.

Education Commission (Further Amendment) 1987

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

5 Short title

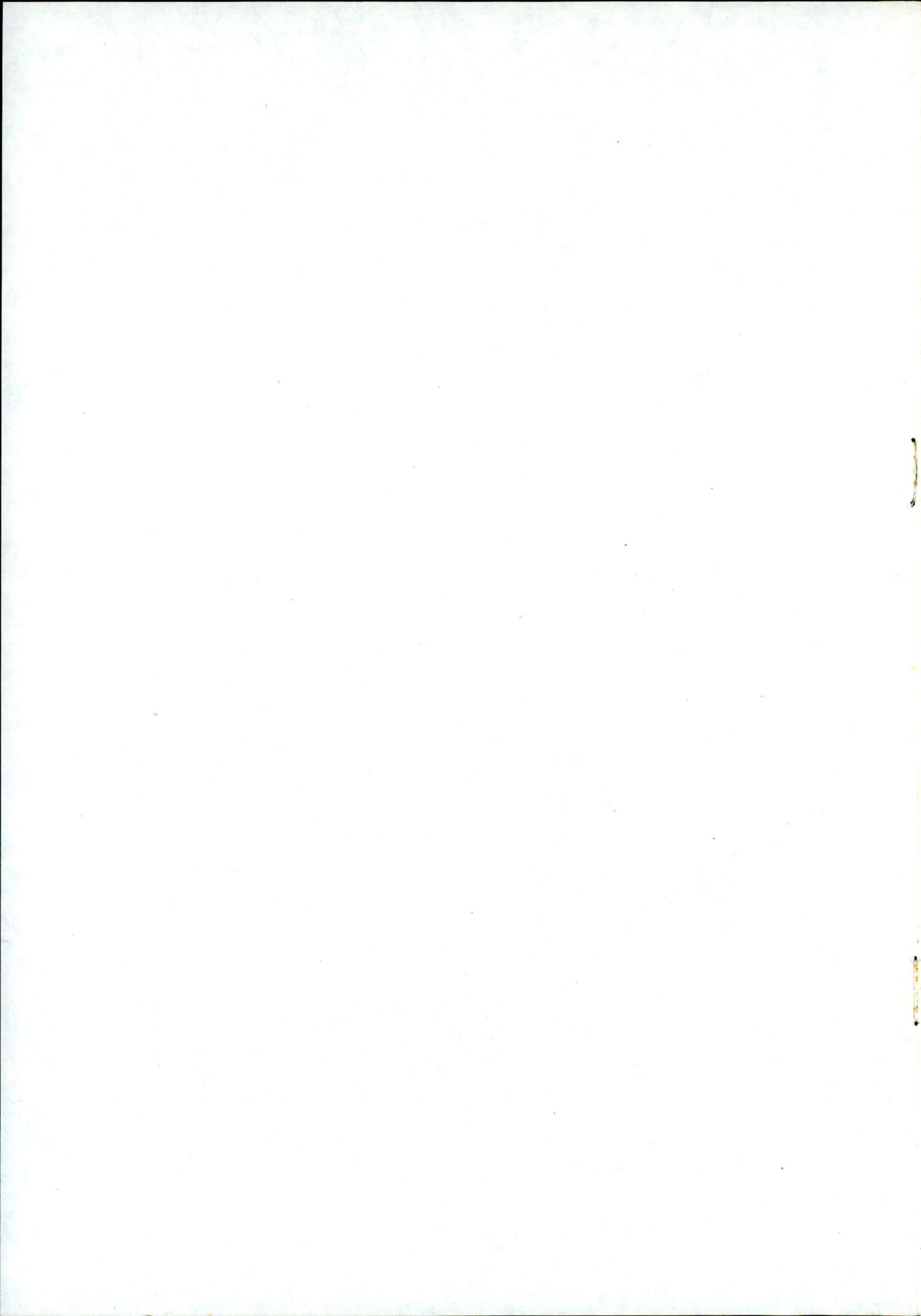
1. This Act may be cited as the "Education Commission (Further Amendment) Act 1987".

Amendment of Act No. 23, 1980

2. The Education Commission Act 1980 is amended by inserting after 10 section 13 (2) the following subsection:

(3) The Acting Chairman, when acting as the Chairman, shall have the capacity of a full-time or part-time member, as may be specified in the terms of the appointment.





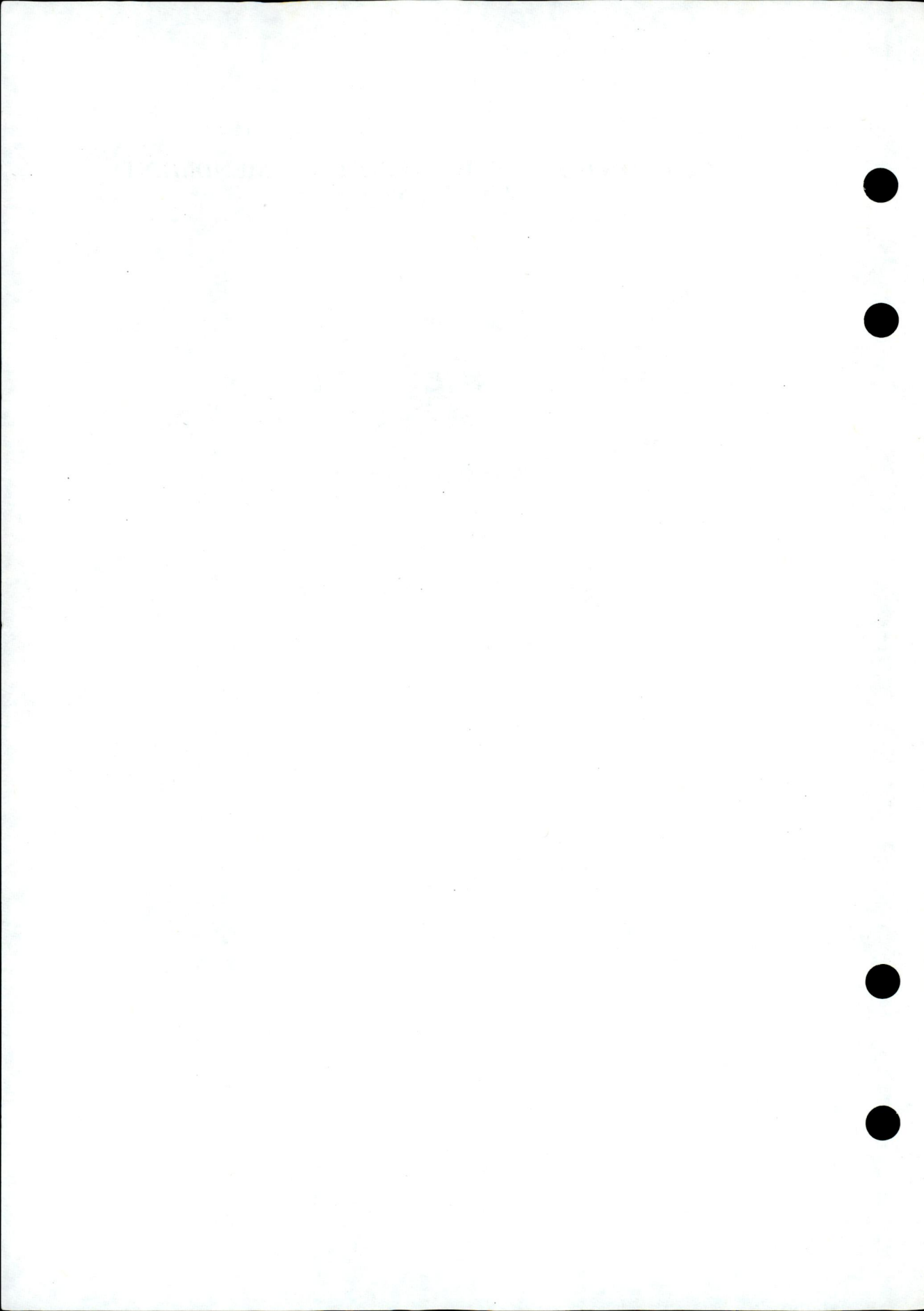

Act No. 114, 1987

An Act to amend the Education Commission Act 1980 so as to enable an Acting Chairman of the Education Commission to be appointed to act either as a full-time or as a part-time member of the Commission. [Assented to 16 June 1987]

Education Commission (Further Amendment) 1987

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

Short title

1. This Act may be cited as the "Education Commission (Further Amendment) Act 1987".

Amendment of Act No. 23, 1980

2. The Education Commission Act 1980 is amended by inserting after section 13 (2) the following subsection:

(3) The Acting Chairman, when acting as the Chairman, shall have the capacity of a full-time or part-time member, as may be specified in the terms of the appointment.
