FORESTRY (CLEARING LICENCES) AMENDMENT BILL 1985

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Western Lands (Amendment) Bill 1985.

The object of this Bill is to amend the Forestry Act 1916 in consequence of the enactment of the proposed Western Lands (Amendment) Act 1985 which confers authority on the Western Lands Commissioner to issue clearing licences in respect of western lands leases (not being leases of land in a State forest or timber reserve).

Clause 1 specifies the short title of the proposed Act.

Clause 2 provides that the proposed Act will (with minor exceptions) commence on the day that Schedule 1 (2) to the Western Lands (Amendment) Bill 1985 commences.

Clause 3 is a formal provision that gives effect to the Schedule of amendments to the Principal Act.

Schedule 1 (1) is a consequential amendment which ensures that a person is not guilty of an offence under the Forestry Act 1916 for anything done in pursuance of a clearing licence issued in respect of a western lands lease under the Western Lands Act 1901.

Schedule 1 (2) prevents the Forestry Commission from issuing clearing licences in respect of western lands leases (not being leases of land in a State forest or timber reserve).


