#### EXPLANATORY NOTE

# (This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Energy Administration Bill 1987.

The object of this Bill is to amend the Gas Act 1986 to enable money payable to the State Energy Research and Development Fund as a consequence of the enactment of the proposed Electricity Development (Amendment) Bill 1987 to be paid into the Fund.

Clause 1 specifies the short title of the proposed Act.

Clause 2 provides that the proposed Act will, with minor exceptions, commence on the same day as the proposed Energy Administration Act 1987.

Clause 3 gives effect to the Schedule of amendments.

Schedule 1 amends section 133 (State Energy Research and Development Fund) of the Principal Act to enable money paid into that Fund by or under any other Act to be paid to that Fund.
