GOVERNMENT GUARANTEES (TOURISM COMMISSION) AMENDMENT BILL, 1984

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Tourism Commission Bill, 1984.

The object of this Bill is to amend section 3B of the Government Guarantees Act, 1934, in consequence of the enactment of the proposed Tourism Commission Act, 1984, so as to enable the Treasurer (upon the recommendation of the Minister administering the latter Act and with the approval of the Governor) to execute certain guarantees for the repayment of money used in the development of tourism.

Government Guarantees (Tourism Commission) Amendment.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

5 Short title.

1. This Act may be cited as the "Government Guarantees (Tourism Commission) Amendment Act, 1984".

Commencement.

- **2.** (1) Sections 1 and 2 shall commence on the date of assent to this 10 Act.
 - (2) Except as provided by subsection (1), this Act shall commence on the day appointed and notified under section 2 (2) of the Tourism Commission Act, 1984.

Amendment of Act No. 57, 1934.

3. The Government Guarantees Act, 1934, is amended by omitting from section 3B the words "Tourist Industry Development Act, 1976" and by inserting instead the words "Tourism Commission Act, 1984".
