**HEALTH INSURANCE LEVIES (ADMINISTRATION)
AMENDMENT BILL 1985**

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Stamp Duties (Amendment) Bill 1985.

The object of this Bill is to provide for the appointment of a Deputy Chief Commissioner for Health Insurance Levies (clause 2 and Schedule 1).

A BILL FOR

An Act to amend the Health Insurance Levies Act 1982 so as to provide for the appointment of a Deputy Chief Commissioner for Health Insurance Levies.

Health Insurance Levies (Administration) Amendment 1985

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

5 Short title

1. This Act may be cited as the "Health Insurance Levies (Administration) Amendment Act 1985".

Amendment of Act No. 159, 1982

2. The Health Insurance Levies Act 1982 is amended in the manner set forth in Schedule 1.

AMENDMENTS TO THE HEALTH INSURANCE LEVIES ACT 1982

(1) Section 4 (1), definition of "Deputy Chief Commissioner"—

15 After the definition of "contributor", insert:

"Deputy Chief Commissioner" means the Deputy Chief Commissioner for Health Insurance Levies referred to in section 6;

(2) (a) Section 6 (2A), (2B)—

20 After section 6 (2), insert:

(2A) There shall be a Deputy Chief Commissioner for Health Insurance Levies, who shall assist the Chief Commissioner in the administration of this Act.

25 (2B) The person for the time being holding office or acting as Deputy Secretary of the Department of Finance shall also hold office as Deputy Chief Commissioner.

(b) Section 6 (6)–(8)—

Omit "the Commissioner" wherever occurring, insert instead "the Deputy Chief Commissioner".

Health Insurance Levies (Administration) Amendment 1985

After section 6 (2), insert:

(2A) There shall be a Deputy Chief Commissioner for Health Insurance Levies, who shall assist the Chief Commissioner in the administration of this Act.

(2B) The person for the time being holding office or acting as Deputy Secretary of the Department of Finance shall also hold office as Deputy Chief Commissioner.

(b) Section 6 (6)–(8)—

Omit "the Commissioner" wherever occurring, insert instead "the Deputy Chief Commissioner".
