# JUSTICES (SYDNEY MARKET AUTHORITY) AMENDMENT BILL 1985

#### EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Sydney Farm Produce Market Authority (Amendment) Bill 1985.

The object of this Bill is to amend section 1001 of the Justices Act 1902, to provide for the enforcement, under Part IVB of that Act, of certain penalty notices that will be issued in consequence of the enactment of the proposed Sydney Farm Produce Market Authority (Amendment) Act 1985.

Clause 1 specifies the short title of the proposed Act.

Clause 2 provides that the proposed Act will, with minor exceptions, commence on the day on which relevant provisions of the Sydney Farm Produce Market Authority (Amendment) Act 1985 commence (being provisions authorising the issue of penalty notices).

Clause 3 effects the amendment described above.

## A BILL FOR

An Act to amend the Justices Act 1902 in consequence of the enactment of the Sydney Farm Produce Market Authority (Amendment) Act 1985.

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

#### 5 Short title

1. This Act may be cited as the "Justices (Sydney Market Authority) Amendment Act 1985".

#### Commencement

- 2. (1) Sections 1 and 2 shall commence on the date of assent to this Act.
- 10 (2) Except as provided by subsection (1), this Act shall commence on the day appointed and notified under section 2 (2) of the Sydney Farm Produce Market Authority (Amendment) Act 1985.

Act No. 136, 1985

An Act to amend the Justices Act 1902 in consequence of the enactment of the Sydney Farm Produce Market Authority (Amendment) Act 1985. [Assented to, 25th November, 1985.]

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

### Short title

1. This Act may be cited as the "Justices (Sydney Market Authority) Amendment Act 1985".

#### Commencement

- 2. (1) Sections 1 and 2 shall commence on the date of assent to this Act.
- (2) Except as provided by subsection (1), this Act shall commence on the day appointed and notified under section 2 (2) of the Sydney Farm Produce Market Authority (Amendment) Act 1985.
