
This Bill is cognate with the Local Government (Movable Dwellings) Amendment Bill 1986.

The object of this Bill is to amend the Land and Environment Court Act 1979 to permit the Land and Environment Court to hear appeals under section 289I of the Local Government Act 1919, as amended by the proposed Local Government (Movable Dwellings) Amendment Act 1986.

Clause 1 specifies the short title of the proposed Act.

Clause 2 provides that the proposed Act will, with minor exceptions, commence on the day on which the substantive provisions of the proposed Local Government (Movable Dwellings) Amendment Act 1986 commence.

Clause 3 effects the amendment described above.











EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the National Parks and Wildlife (Marine Mammals Protection) Amendment Bill 1986.

The object of this Bill is to amend the Land and Environment Court Act 1979 so as to provide for the hearing of certain proceedings in relation to offences with respect to marine mammals and other protected fauna under the National Parks and Wildlife Act 1974 by the Land and Environment Court.

Clause 1 specifies the short title of the proposed Act.

Clause 2 provides that the proposed Act will, with minor exceptions, commence on the commencement of the proposed National Parks and Wildlife (Marine Mammals Protection) Amendment Act 1986.

Clause 3 is a formal provision which gives effect to the Schedule of amendments to the Principal Act.

Schedule 1 enables proceedings to be brought in the Land and Environment Court in its summary jurisdiction in respect of offences against sections 98, 99 and 101 of the National Parks and Wildlife Act 1974 (offences relating to the taking, killing or possession of marine mammals and other protected fauna).


