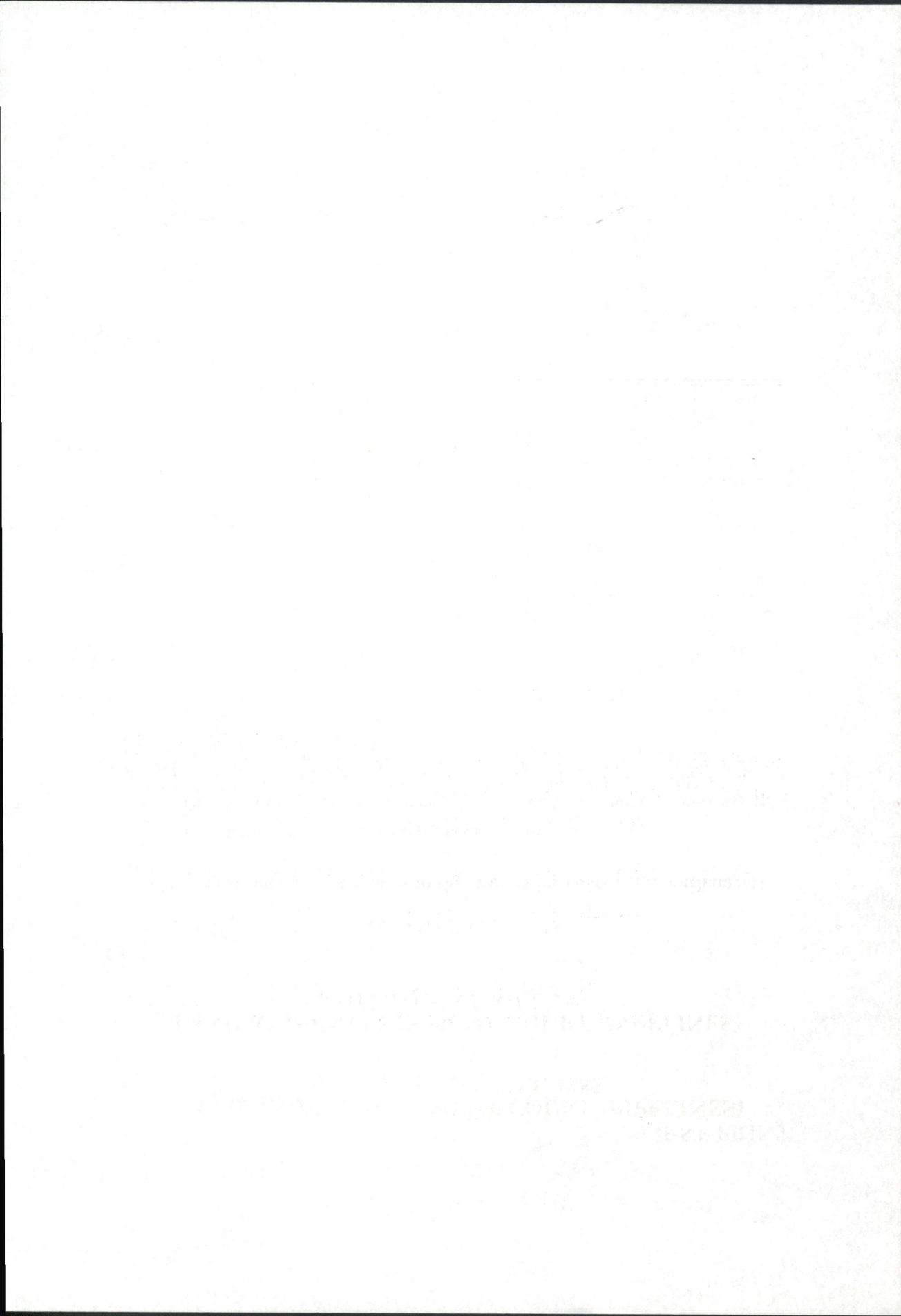
**LAND AND ENVIRONMENT COURT (PIPELINES)

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Pipelines (Amendment) Bill 1985.

The object of this Bill is to amend the Land and Environment Court Act 1979 in relation to the jurisdiction to be conferred on the Land and Environment Court by section 60B of the Pipelines Act 1967, as amended by the proposed Pipelines (Amendment) Act 1985 (clause 3).

Land and Environment Court (Pipelines) Amendment 1985

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

5 Short title

1. This Act may be cited as the "Land and Environment Court (Pipelines) Amendment Act 1985".

Commencement

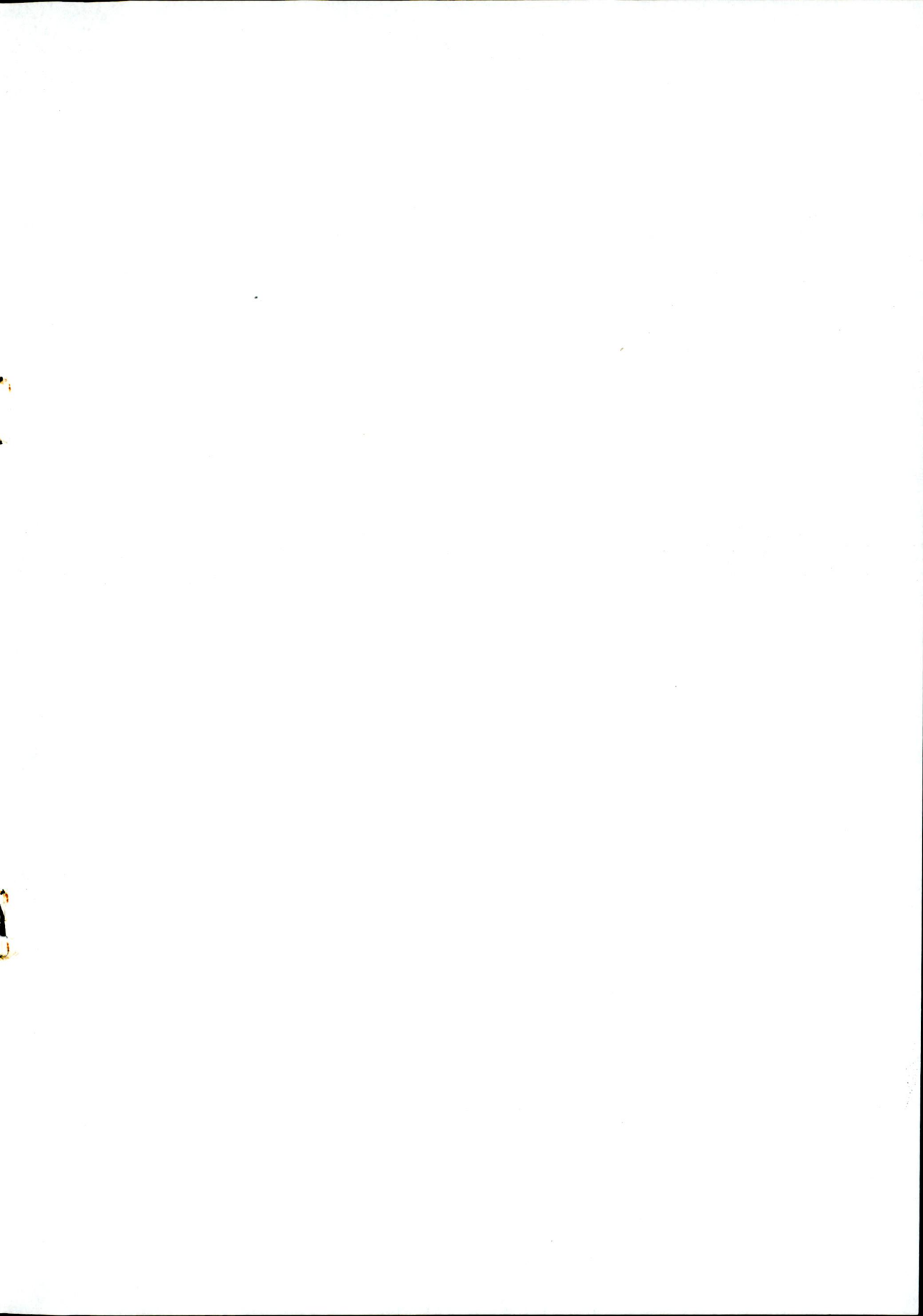
2. (1) Except as provided by subsection (2), this Act shall commence

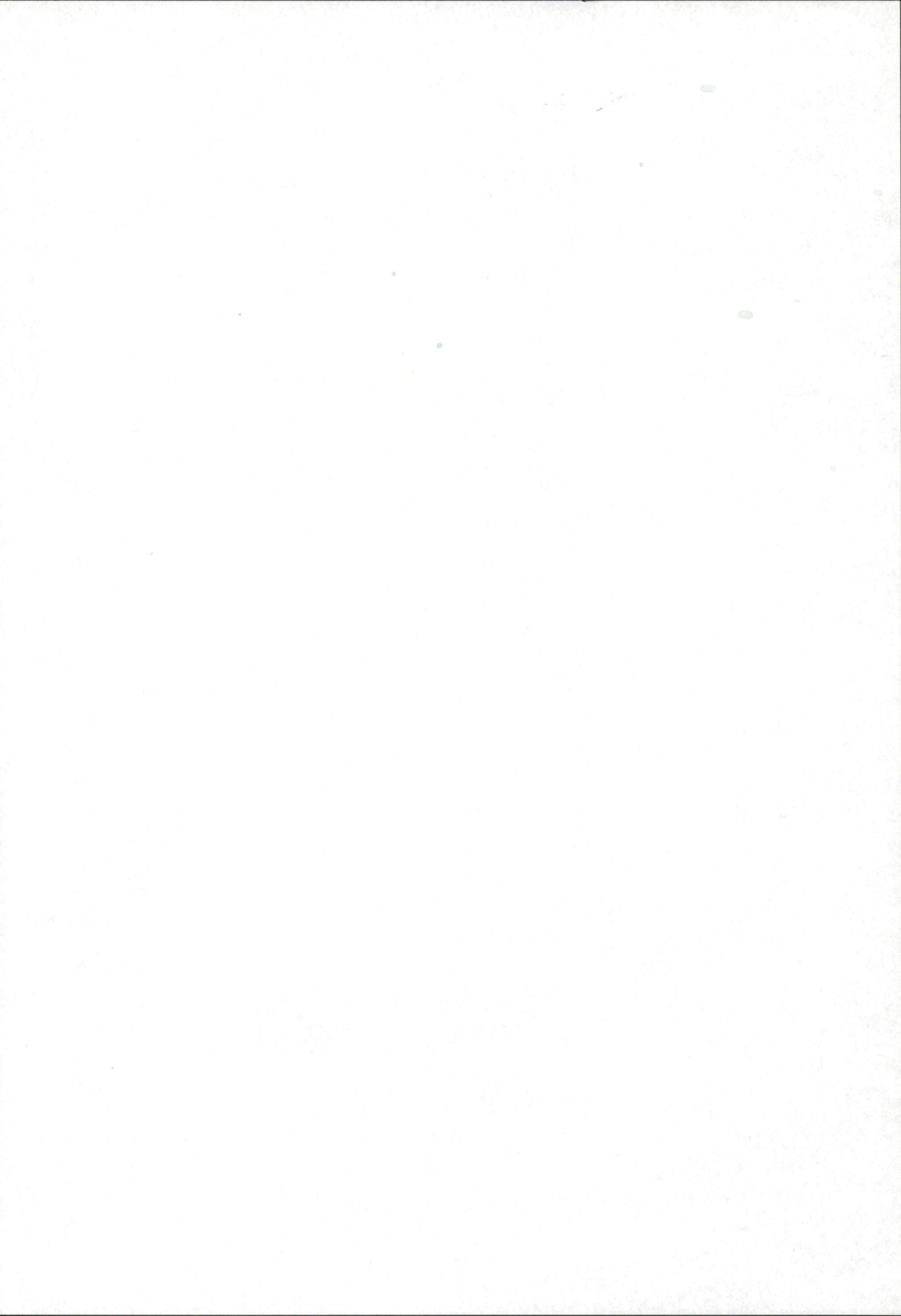

Land and Environment Court (Pipelines) Amendment 1985

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

Short title

1. This Act may be cited as the "Land and Environment Court (Pipelines) Amendment Act 1985".

Commencement
