LAND TAX (AMENDMENT) BILL 1985

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Valuation of Land (Amendment) Bill 1985.

The object of this Bill is to substitute references in the Land Tax Act 1956 to land value with references to adjusted value as a consequence of the enactment of the proposed Valuation of Land (Amendment) Act 1985 and the proposed Land Tax Management (Amendment) Act 1985.

Clause 1 specifies the short title of the proposed Act.

Clause 2 makes the relevant amendments to the Principal Act.

A BILL FOR

An Act to amend the Land Tax Act 1956 as a consequence of the enactment of the Valuation of Land (Amendment) Act 1985 and the Land Tax Management (Amendment) Act 1985.

Land Tax (Amendment) 1985

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

5 Short title

1. This Act may be cited as the "Land Tax (Amendment) Act 1985".

Amendment of Act No. 27, 1956

2. The Land Tax Act 1956 is amended by omitting from sections 3A (3) (b), 3C (3) (c) and 4 (1), (2) and (3) the words "land value" wherever

Land Tax (Amendment) 1985

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

Short title

1. This Act may be cited as the "Land Tax (Amendment) Act 1985".
