

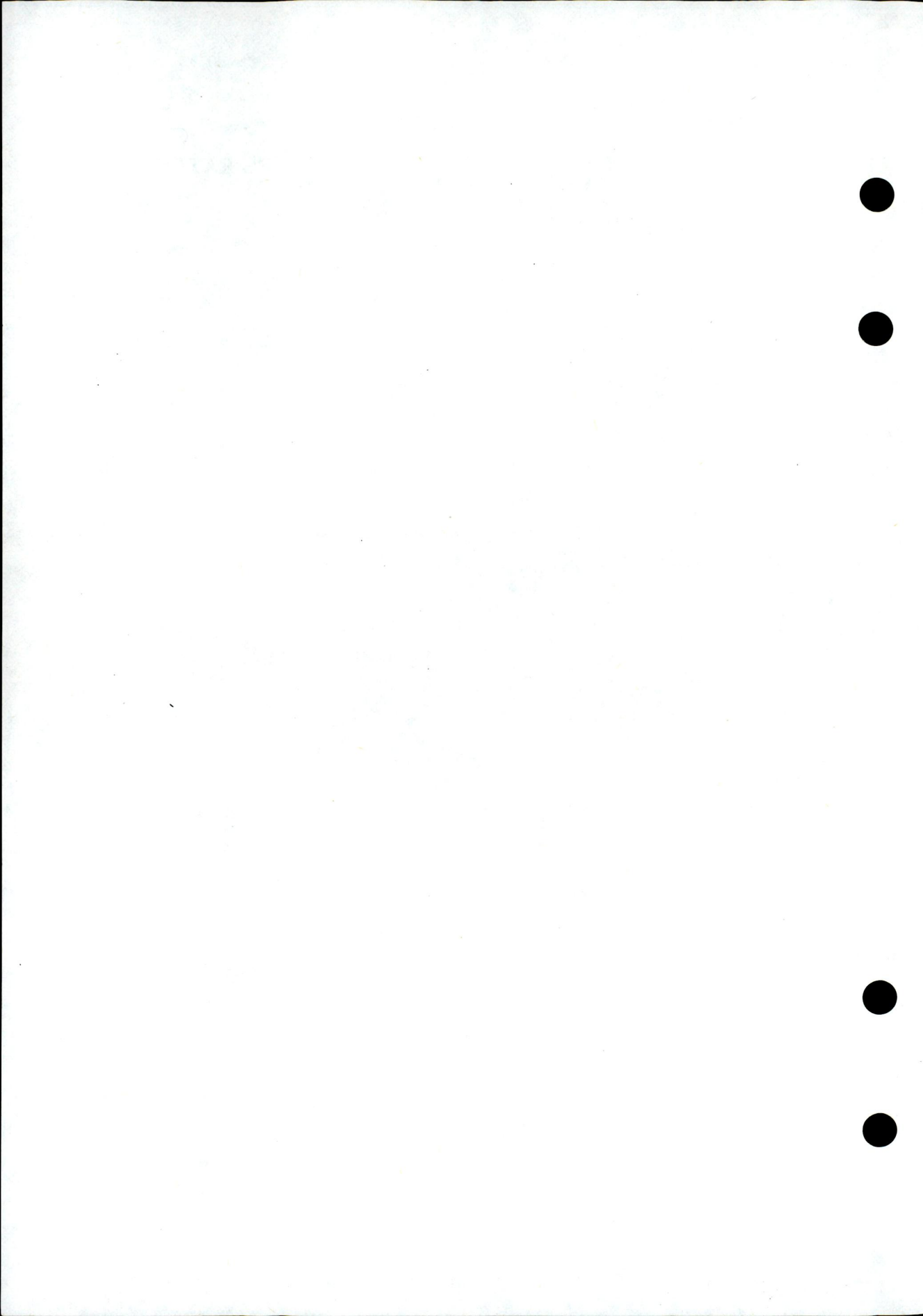

Act No. 234, 1987

An Act to amend the Local Government Act 1919 to increase rate rebates for pensioners. [Assented to 16 December 1987]

Local Government (Pensioners Rates) Amendment 1987

The Legislature of New South Wales enacts:

Short title

1. This Act may be cited as the Local Government (Pensioners Rates) Amendment Act 1987.

Amendment of Act No. 41, 1919, s. 160AA (Reduction of rates payable by certain classes of pensioners)

2. The Local Government Act 1919 is amended by omitting from section 160AA (4A) and (6A) the matter "\$75" wherever occurring and by inserting instead the matter "\$87.50".

Application of amendments

3. The amendments made by this Act do not apply to a rate levied in respect of the 1987 rating year.

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Local Government (Rates and Charges) Bill 1987.

The object of this Bill is to increase the maximum amount of the rebate of an eligible pensioner's rates—

- (a) in the case of water rates—from \$75 to \$87.50; and
- (b) in the case of sewerage rates—from \$75 to \$87.50.

Clause 1 specifies the short title of the proposed Act.

Clause 2 amends section 160AA of the Principal Act (reduction of rates payable by certain classes of pensioners) to give effect to the object described above.

Clause 3 provides that the amendments do not apply to rates levied in 1987.
