**LOCAL GOVERNMENT (PLAN REGISTRATION)

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Conveyancing (Plan Registration) Amendment Bill 1986.

The object of this Bill is to make a minor amendment to the Local Government Act 1919 as a consequence of amendments intended to be made to the Conveyancing Act 1919 in relation to the registration and recording of plans.

Clause 1 specifies the short title of the proposed Act.

Clause 2 provides that the proposed Act will, with minor exceptions, commence on the commencement of the proposed Conveyancing (Plan Registration) Amendment Act 1986.

Clause 3 amends section 327AA of the Local Government Act 1919 as a consequence of the proposed repeal and re-enactment of Division 3 of Part XXIII of the Conveyancing Act 1919 by the proposed Conveyancing (Plan Registration) Amendment Act 1986.

Local Government (Plan Registration) Amendment 1986

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

1. This Act may be cited as the "Local Government (Plan Registration) Amendment Act 1986".

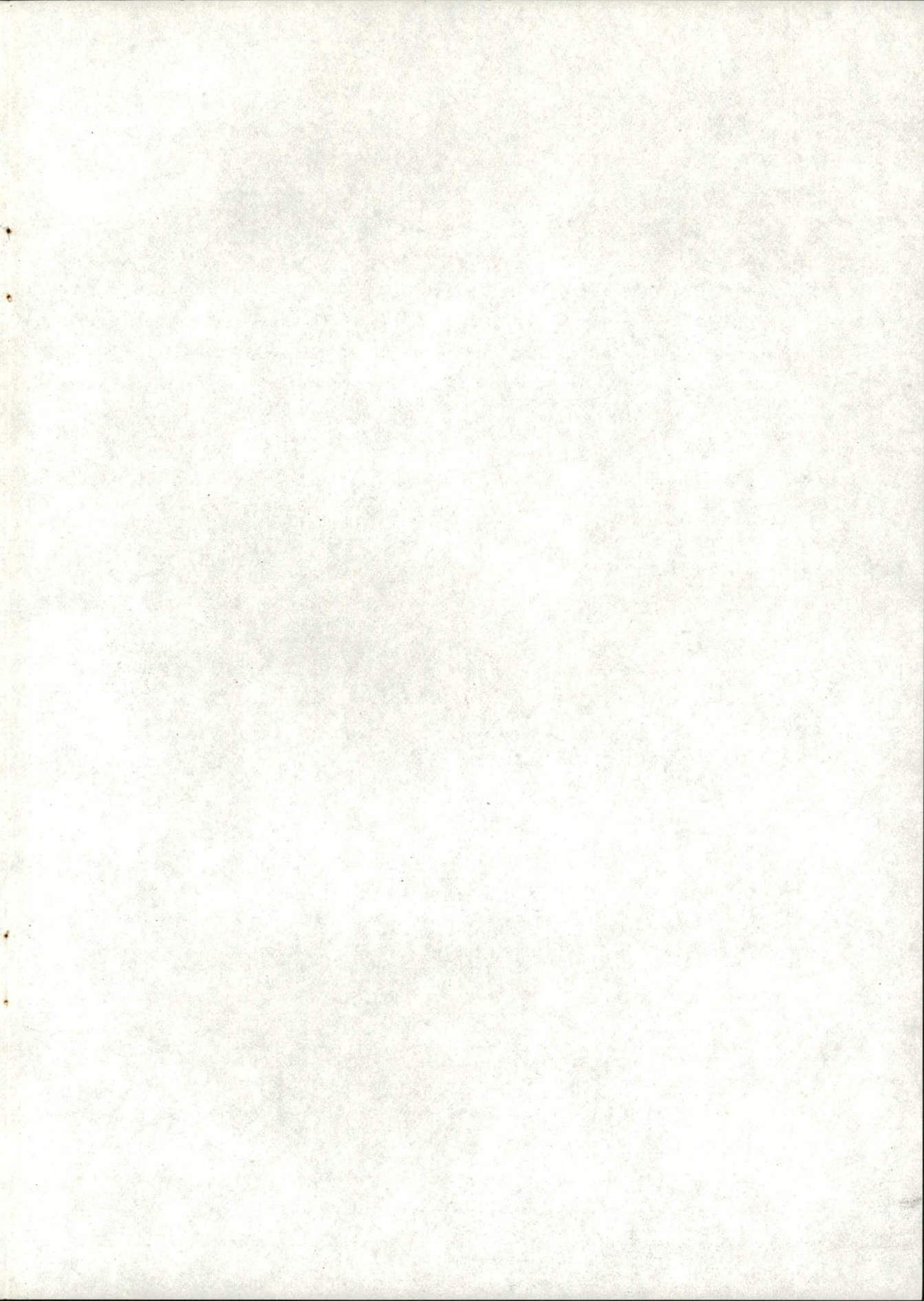
Commencement
