LOCAL GOVERNMENT (TRAFFIC) AMENDMENT BILL 1985

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Metropolitan Traffic (Amendment) Bill 1985.

The object of this Bill is to amend the Local Government Act 1919 as a consequence of the enactment of the proposed Metropolitan Traffic (Amendment) Act 1985 which changes the name of the Metropolitan Traffic Act 1900 to the General Traffic Act 1900 and extends its operation to the whole of the State.

Clause 1 specifies the short title of the proposed Act.

Clause 2 provides that the proposed Act will (with minor exceptions) commence on the day appointed under section 2 (2) of the proposed Metropolitan Traffic (Amendment) Act 1985.

Clause 3 is a formal provision that gives effect to the Schedule of amendments.

Clause 4 repeals Ordinance No. 34 under the Principal Act, which generally regulates non-motor vehicle traffic in local government areas outside metropolitan transport districts, as the Metropolitan Traffic Act 1900 will now apply to those areas.

Schedule 1 (1) is a consequential amendment which changes references to the Metropolitan Traffic Act 1900 to references to the General Traffic Act 1900.

Schedule 1 (2) is a consequential amendment which is necessary because the Metropolitan Traffic Act 1900 will now have operation throughout the State.

Schedule 1 (3) omits section 270 of the Principal Act as a consequence of the amendment made by Schedule 1 (4) to the proposed Metropolitan Traffic (Amendment) Act 1985 which makes it clear that the Metropolitan Traffic Act 1900 will apply to footpaths.
