MISCELLANEOUS ACTS (ANNUAL REPORTS— DEPARTMENTS) AMENDMENT BILL 1985

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Annual Reports (Departments) Bill 1985.

The object of this Bill is to amend certain Acts as a consequence of, and in connection with, the enactment of the proposed Annual Reports (Departments) Act 1985.

Clause 1 specifies the short title of the proposed Act.

Clause 2 provides that the proposed Act will, with minor exceptions, commence on the commencement of the proposed Annual Reports (Departments) Act 1985.

Clause 3 is a formal provision that gives effect to the Schedule of amendments.

Schedule 1 contains the Acts to be amended. Those Acts and the effect of the amendments are as follows:

The Annual Reports (Statutory Bodies) Act 1984 is amended in the following respects:

Section 7 is amended to require the financial statements of a statutory body to be prepared (in addition to the provisions of Division 3 of Part III of the Public Finance and Audit Act 1983) in accordance with the regulations under that Act and to enable a statutory body, with the approval of the Treasurer, to dispense, not only with a detailed budget for the financial year to which the statements relate, but also with an outline budget for the next following financial year.

Section 13 is amended to provide that the Treasurer may extend the time limits within which a statutory body is required to comply with the reporting provisions of the Annual Reports (Statutory Bodies) Act 1984 only after consultation with the appropriate Minister.

Section 16 is amended to provide that the Public Accounts Committee's report on a proposal to amend the Annual Reports (Statutory Bodies) Act 1984 or to make a regulation under that Act shall be a report to the Treasurer.

The Child Welfare Act 1939, the Corporate Affairs Commission Act 1981, the Technical and Further Education Act 1974 and the Valuation of Land Act 1916 are each amended by the omission of a provision which requires the preparation of an annual report as the reporting bodies under those Acts will now be required to report under the proposed Annual Reports (Departments) Act 1985.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

5 Short title

1. This Act may be cited as the "Miscellaneous Acts (Annual Reports— Departments) Amendment Act 1985".

Commencement

2. (1) Sections 1 and 2 shall commence on the date of assent to this Act.

10 (2) Except as provided by subsection (1), this Act shall commence on the day appointed and notified under section 2 (2) of the Annual Reports (Departments) Act 1985.




