
# MISCELLANEOUS ACTS (DEATH PENALTY ABOLITION) AMENDMENT BILL, 1985

### **EXPLANATORY NOTE**

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Crimes (Death Penalty Abolition) Amendment Bill, 1985.

The object of this Bill is, in consequence of the enactment of the proposed Crimes (Death Penalty Abolition) Amendment Act, 1985, to remove certain references to the death penalty which appear in the various Acts specified in Schedule 1.

## A BILL FOR

An Act to amend certain Acts as a consequence of the enactment of the Crimes (Death Penalty Abolition) Amendment Act, 1985, and for other purposes.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

### 5 Short title.

1. This Act may be cited as the "Miscellaneous Acts (Death Penalty Abolition) Amendment Act, 1985".




