MISCELLANEOUS ACTS (DRUG MISUSE AND TRAFFICKING) AMENDMENT BILL 1985

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Drug Misuse and Trafficking Bill 1985.

The object of this Bill is to amend certain Acts as a consequence of the enactment of the proposed Drug Misuse and Trafficking Act 1985.

Clause 1 specifies the short title of the proposed Act.

Clause 2 provides that the proposed Act will, with minor exceptions, commence on the commencement of the proposed Drug Misuse and Trafficking Act 1985.

Clause 3 is a formal provision that gives effect to the Schedule of amendments.

Schedule 1 specifies the Acts to be amended and the terms of each amendment. Except in the case of the Poisons Act 1966, each amendment substitutes a reference to a provision of the Poisons Act 1966 with a reference to the corresponding provision of the proposed Drug Misuse and Trafficking Act 1985. The Poisons Act 1966 is amended in the following respects:

Section 2 (division of Act) is omitted by way of statute law revision.

Section 4 (interpretation) is amended to omit certain definitions which are no longer required for the purposes of the Act and to make consequential amendments.

Section 5 (exemption from operation of Act) is amended consequentially.

The heading to Part IV is amended consequentially.

Section 21 (offences relating to prepared opium and other drugs of addiction), 22 (forging, etc., prescriptions) and 23 (obtaining drug by false representations) are omitted as the matters dealt with in these sections are dealt with in the proposed Drug Misuse and Trafficking Act 1985.

Divisions 3 (Prohibited Drugs) and 4 (Prohibited Plants) of Part IV are omitted as the matters dealt with in these Divisions are dealt with in the proposed Drug Misuse and Trafficking Act 1985.

Section 43 (powers of entry and search) is amended consequentially.

Section 43B (powers of detention and search) is amended consequentially.

- Sections 45A (certain offences punishable on indictment) and 45AB (certain summary proceedings to become committal proceedings) are omitted as the matters dealt with in these sections are dealt with in the proposed Drug Misuse and Trafficking Act 1985.
- Section 46 (publication, etc., of proclamations, certain orders and regulations) is amended consequentially.

A BILL FOR

An Act to amend certain Acts as a consequence of the enactment of the Drug Misuse and Trafficking Act 1985.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

5 Short title

1. This Act may be cited as the "Miscellaneous Acts (Drug Misuse and Trafficking) Amendment Act 1985".

Commencement

2. (1) Sections 1 and 2 shall commence on the date of assent to this 10 Act.

(2) Where the day appointed and notified under section 2 (2) of the Firearms and Dangerous Weapons (Amendment) Act 1985 in respect of Schedule 6 (2) (e) to that Act is later than the day appointed and notified under section 2 (2) of the Drug Misuse and Trafficking Act 1985, the
15 amendment made in Schedule 1 to this Act to the Firearms and Dangerous Weapons Act 1973 shall commence on the firstmentioned day.

(3) Except as provided by subsections (1) and (2), this Act shall commence on the day appointed and notified under section 2 (2) of the Drug Misuse and Trafficking Act 1985.

An Act to amend certain Acts as a consequence of the enactment of the Drug Misuse and Trafficking Act 1985. [Assented to, 18th December, 1985.]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

Short title

1. This Act may be cited as the "Miscellaneous Acts (Drug Misuse and Trafficking) Amendment Act 1985".

Commencement

2. (1) Sections 1 and 2 shall commence on the date of assent to this Act.

(2) Where the day appointed and notified under section 2 (2) of the Firearms and Dangerous Weapons (Amendment) Act 1985 in respect of Schedule 6 (2) (e) to that Act is later than the day appointed and notified under section 2 (2) of the Drug Misuse and Trafficking Act 1985, the amendment made in Schedule 1 to this Act to the Firearms and Dangerous Weapons Act 1973 shall commence on the firstmentioned day.

(3) Except as provided by subsections (1) and (2), this Act shall commence on the day appointed and notified under section 2 (2) of the Drug Misuse and Trafficking Act 1985.
