

# Act No. 201, 1987

An Act to amend certain Acts with respect to the members and procedure of the Archives Authority, the Australian Museum Trust, the Library Council and the Trustees of the Museum of Applied Arts and Sciences. [Assented to 4 December 1987]

# The Legislature of New South Wales enacts:

### Short title

1. This Act may be cited as the Miscellaneous Acts (Heritage Authorities) Amendment Act 1987.

#### Commencement

2. This Act shall commence on a day to be appointed by proclamation.

#### Amendment of certain Acts

3. The Acts listed in Schedule 1 are amended as set out in that Schedule.

## Continuation in office of existing presiding officers and members

- **4.** (1) A person who, immediately before the commencement of this Act, held office as—
  - (a) Chairman, Deputy Chairman or member of the Archives Authority of New South Wales constituted by the Archives Act 1960;
  - (b) President, Deputy President or trustee of the Australian Museum Trust constituted by the Australian Museum Trust Act 1975;
  - (c) President, Deputy President or member of the Library Council of New South Wales constituted by the Library Act 1939; or
  - (d) President or trustee of The Trustees of the Museum of Applied Arts and Sciences constituted by the Museum of Applied Arts and Sciences Act 1945.

does not cease to hold office because of this Act but shall be deemed to have been appointed to, or nominated for, that office under the relevant Act, as amended by this Act.

(2) The Chairman and Deputy Chairman of the Archives Authority of New South Wales shall, for the purposes of subsection (1), be deemed to be the Chairperson and Deputy Chairperson of that Authority.



#### EXPLANATORY NOTE

#### (This Explanatory Note relates to this Bill as introduced into Parliament)

The object of this Bill is to amend certain Acts with respect to the members and procedure of the Archives Authority, the Australian Museum Trust, the Library Council and the Trustees of the Museum of Applied Arts and Sciences.

Clause 1 specifies the short title of the proposed Act.

Clause 2 provides that the proposed Act will commence on a day to be appointed by proclamation.

Clause 3 gives effect to the amendments contained in Schedule 1.

Clause 4 provides that the existing appointments to the various statutory authorities are not affected by the proposed Act.

#### Schedule 1 amends-

- (a) the Archives Act 1960 to enable the Minister to nominate the Chairperson of the Archives Authority (instead of the Governor appointing the Chairperson);
- (b) the Australian Museum Trust Act 1975—
  - (i) to enable the Minister to nominate the President of the Australian Museum Trust (instead of the trustees electing the President); and
  - (ii) to increase the quorum for a meeting of the Trust from 5 to 6 trustees;
- (c) the Library Act 1939-
  - (i) to reduce the number of members of the Library Council from 13 to 10;
  - (ii) to enable the Minister to nominate the President of the Council (instead of the members electing the President); and
  - (iii) to increase the quorum for a meeting of the Council from 5 to 6 members; and
- (d) the Museum of Applied Arts and Sciences Act 1945—

# Miscellaneous Acts (Heritage Authorities) Amendment 1987

- (i) to increase the number of trustees of the Museum of Applied Arts and Sciences from 7 to 9;
- (ii) to enable the Minister to nominate the President of the Trustees (instead of the members electing the President); and
- (iii) to increase the quorum for a meeting of the Trustees from 4 to 5 trustees.


