

**MISCELLANEOUS ACTS (PRICKLY PEAR) REPEAL AND

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Prickly Pear Bill 1987.

The objects of this Bill are to repeal the Prickly-pear Act 1924 (and other Acts amending that Act) and to amend certain other Acts as a result of the enactment of the proposed Prickly Pear Act 1987.

Clause 1 specifies the short title of the proposed Act.

Clause 2 provides that the proposed Act will commence when the proposed Prickly Pear Act 1987 commences.

Clause 3 gives effect to the Schedule of repeals.

Clause 4 gives effect to the Schedule of amendments.

Schedule 1 repeals the Prickly-pear Act 1924 and certain other Acts amending that Act.

Schedule 2 amends various Acts to update references as a result of the repeal of the Prickly-pear Act 1924 and the enactment of the proposed Prickly Pear Act 1987.
