MISCELLANEOUS ACTS (STATE SUPERANNUATION FUND) AMENDMENT BILL, 1984 (No. 2)

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the New South Wales Retirement Benefits (Amendment) Bill, 1984.

The object of this Bill is to amend certain Acts to provide that persons who become officers or employees of statutory authorities constituted under those Acts and who cease to be employees within the meaning of the Superannuation Act, 1916, are not entitled to continue to contribute to the State Superannuation Fund.

A BILL FOR

An Act to amend certain Acts to vary provisions that allow certain persons to continue to contribute to the State Superannuation Fund after ceasing to be employees within the meaning of the Superannuation Act, 1916.

Miscellaneous Acts (State Superannuation Fund) Amendment.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

5 Short title.

1. This Act may be cited as the "Miscellaneous Acts (State Superannuation Fund) Amendment Act, 1984".
