MOTOR TRAFFIC (RANDOM BREATH TESTING) AMENDMENT BILL 1985

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

The object of this Bill is to amend the Motor Traffic Act 1909, so as to enable the continuation of random breath testing, by repealing certain provisions which allow for the operation of the scheme only until 16 December 1985.


Clause 1 specifies the short title of the proposed Act.

Clause 2 is a formal provision that gives effect to the Schedule of amendments to the Principal Act.

Schedule 1 (1) repeals section 4E(2) and (2C) of the Principal Act. Section 4E(2) specifies the grounds that had to be met before a member of the police force was able to require a person to undergo a breath test before the introduction of random breath testing. Section 4E(2C) provides that the power conferred by section 4E(2A) to conduct random breath testing shall not be effective after 16 December 1985.

Schedule 1 (2)-(5) omit references to the repealed provisions.
