
MOTOR VEHICLES (PENSIONERS TAXATION AND REGISTRATION) AMENDMENT BILL, 1984

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

The objects of this Bill are to exempt certain motor vehicles owned by certain pensioners from—

- (a) motor vehicles tax levy and motor vehicles weight tax payable under the Motor Vehicles Taxation Management Act, 1949 (Schedule 1); and
 - (b) certain registration fees payable under the Motor Traffic Act, 1909 (Schedule 2).

A BILL FOR

An Act to amend the Motor Vehicles Taxation Management Act, 1949, to exempt certain pensioners' motor vehicles from tax and to amend the Motor Traffic Regulations, 1935, to exempt those vehicles from certain registration fees.

Motor Vehicles (Pensioners Taxation and Registration) Amendment.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

5 Short title.

1. This Act may be cited as the "Motor Vehicles (Pensioners Taxation and Registration) Amendment Act, 1984".

Commencement.

2. (1) Sections 1 and 2 shall commence on the date of assent to this
10 Act.

(2) Except as provided by subsection (1), this Act shall commence on 1st July, 1984.

Act No. 41, 1984.

An Act to amend the Motor Vehicles Taxation Management Act, 1949, to exempt certain pensioners' motor vehicles from tax and to amend the Motor Traffic Regulations, 1935, to exempt those vehicles from certain registration fees. [Assented to, 13th June, 1984.]

Motor Vehicles (Pensioners Taxation and Registration) Amendment.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the "Motor Vehicles (Pensioners Taxation and Registration) Amendment Act, 1984".

Commencement.

2. (1) Sections 1 and 2 shall commence on the date of assent to this Act.

(2) Except as provided by subsection (1), this Act shall commence on 1st July, 1984.

- (b) shall be entitled to an exemption from payment of the prescribed fee in respect of 2 motor vehicles where—
- (i) the pensioner and another pensioner are the joint registered owners of the motor vehicles; and
 - (ii) the pensioners referred to in subparagraph (i) are married to each other or reside in the same household.
