NATIONAL PARKS AND WILDLIFE (ADJUSTMENT OF AREA) BILL, 1984

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

The objects of this Bill are to provide for the excision from Ku-ring-gai Chase National Park, and for the vesting in the Commissioner for Main Roads, of—

- (a) certain land comprising about 27 hectares between Cowan and Berowra on which part of the Sydney to Newcastle Freeway and associated works are constructed: and
- (b) certain land comprising about 99 hectares between Wahroonga and a point north of Berowra required for or in connection with the construction of a part of the Sydney to Newcastle Freeway and associated works.

The Bill contains the following provisions:-


Clause 1. Short title.

Clause 2. Interpretation.

Clause 3 excises from Ku-ring-gai Chase National Park land required or used for or in connection with the construction of a part of the Sydney to Newcastle Freeway and associated works.

Clause 4 vests the lands excised under clause 3 in the Commissioner for Main Roads.

Schedule 1 contains a description of the land referred to in clause 3.

A BILL FOR

An Act to excise from Ku-ring-gai Chase National Park land required or used for or in connection with the construction of part of the Sydney to Newcastle Freeway and to vest that land in the Commissioner for Main Roads.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

5 Short title.

1. This Act may be cited as the "National Parks and Wildlife (Adjustment of Area) Act, 1984".

Interpretation.

2. In this Act, "reservation" means a reservation by or under the National Parks and Wildlife Act, 1967 (being a reservation of land deemed to be reserved as a national park under the National Parks and Wildlife Act, 1974).

Excision of land from Ku-ring-gai Chase National Park.

3. The reservation of land as Ku-ring-gai Chase National Park is, to the 15 extent that that reservation applies to the land described in Schedule 1, revoked.

Vesting of land in the Commissioner for Main Roads.

4. The land described in Schedule 1 is vested in the Commissioner for Main Roads for the purposes of the Main Roads Act, 1924.



Act No. 141, 1984.

An Act to excise from Ku-ring-gai Chase National Park land required or used for or in connection with the construction of part of the Sydney to Newcastle Freeway and to vest that land in the Commissioner for Main Roads. [Assented to, 4th December, 1984.]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the "National Parks and Wildlife (Adjustment of Area) Act, 1984".

Interpretation,

2. In this Act, "reservation" means a reservation by or under the National Parks and Wildlife Act, 1967 (being a reservation of land deemed to be reserved as a national park under the National Parks and Wildlife Act, 1974).

Excision of land from Ku-ring-gai Chase National Park.

3. The reservation of land as Ku-ring-gai Chase National Park is, to the extent that that reservation applies to the land described in Schedule 1. revoked.

Vesting of land in the Commissioner for Main Roads.

4. The land described in Schedule 1 is vested in the Commissioner for Main Roads for the purposes of the Main Roads Act, 1924.
