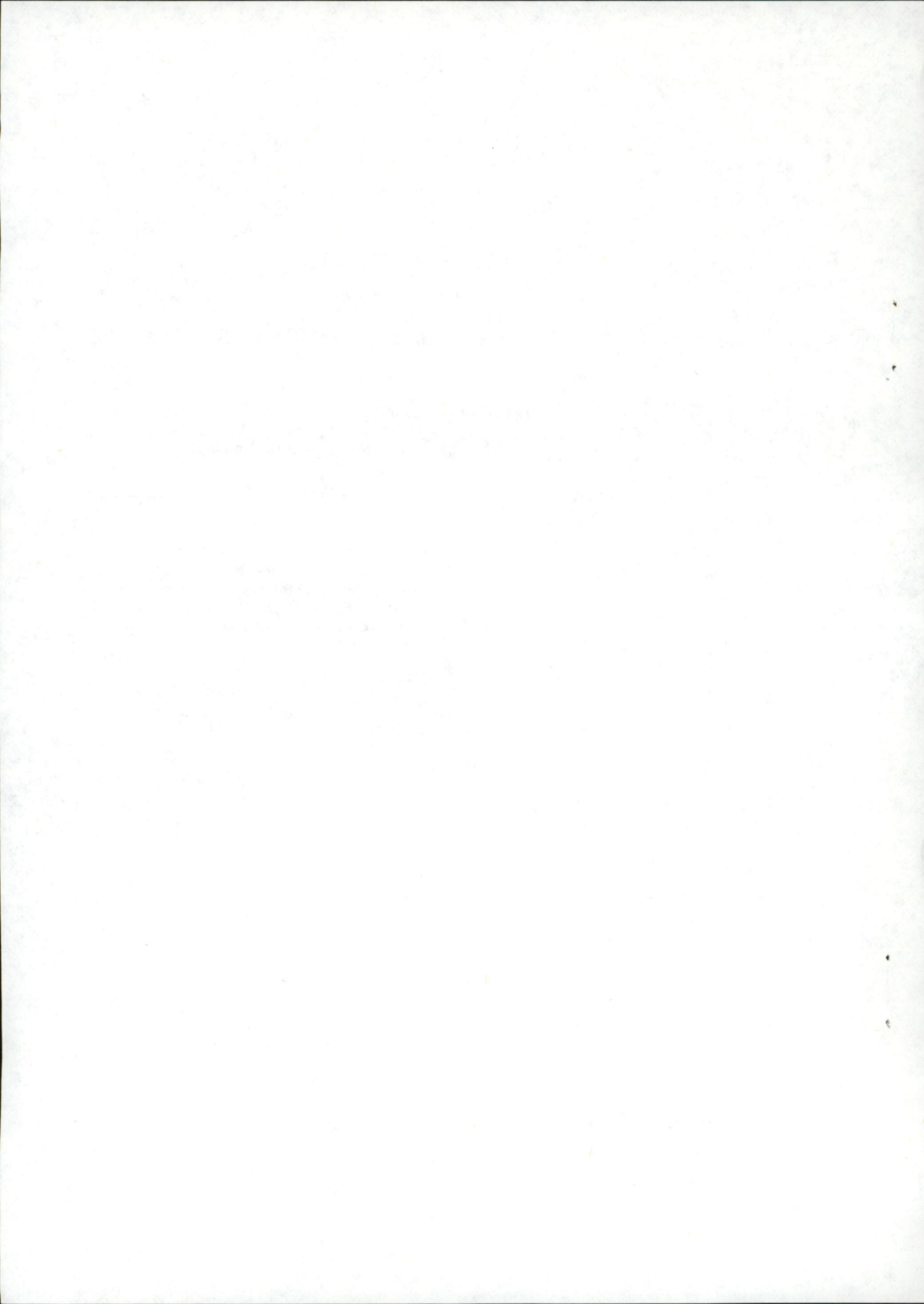
### **EXPLANATORY NOTE**

**(This Explanatory Note relates to this Bill as introduced into Parliament)**

This Bill is cognate with the Police Regulation (Superannuation) Amendment Bill, 1984.

The object of this Bill is to amend the Police Regulation Act, 1899, consequent upon and in connection with the proposed enactment of the Police Regulation (Superannuation) Amendment Act, 1984. In particular, the Bill repeals a provision authorising the making of rules for the purposes of the Police Regulation (Superannuation) Act, 1906, as the consequence of the proposed inclusion in that Act of a provision authorising the making of regulations for that purpose.

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

**5 Short title.**

1. This Act may be cited as the "Police Regulation (Rules) Amendment Act, 1984".

**Commencement.**

2. (1) Sections 1 and 2 shall commence on the date of assent to this
