

**PREVENTION OF CRUELTY TO ANIMALS
(AMENDMENT) BILL, 1985**

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

The object of this Bill is to amend the Prevention of Cruelty to Animals Act, 1979, so as—

- (a) to prohibit the use of premises for the purpose of conducting bull-fights (Schedule 1 (2));
 - (b) to prohibit the advertisement, promotion and conduct of bull-fights (Schedule 1 (3)); and
 - (c) to make other provisions of a minor, consequential or ancillary nature.

A BILL FOR

An Act to amend the Prevention of Cruelty to Animals Act, 1979, so as to prohibit the advertisement, promotion and conduct of bull-fights; and for other purposes.

Prevention of Cruelty to Animals (Amendment) 1985

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

5 Short title.

1. This Act may be cited as the "Prevention of Cruelty to Animals (Amendment) Act, 1985".

Amendment of Act No. 200, 1979.

2. The Prevention of Cruelty to Animals Act, 1979, is amended in the
10 manner set forth in Schedule 1.

(b) teases a bull, or does any other thing in relation to a bull, in a manner that is likely to cause the bull to fight or to suffer pain or injury; or

whether or not for the purpose of causing the bull to fight;


 Penalty: \$1,000 or imprisonment for 6 months, or both.



Prevention of Cruelty to Animals (Amendment) 1985
