## PRICES REGULATION (AMENDMENT) BILL 1986

NEW SOUTH WALES



### EXPLANATORY NOTE

**(This Explanatory Note relates to this Bill as introduced into Parliament)**

The Statutory and Other Offices Remuneration (Prices Commission) Amendment Bill 1986 is cognate with this Bill.

The object of this Bill is to amend the Prices Regulation Act 1948 so as —

- (a) to change the office of Chairman of the Prices Commission to the office of Chairperson of that Commission;
- (b) to provide that a person appointed as Chairperson of the Prices Commission may be appointed as a part-time or a full-time commissioner; and
- (c) to ensure that a part-time commissioner may be appointed to other full-time statutory positions.

---

Clause 1 specifies the short title of the proposed Act.

Clause 2 provides that the proposed Act will, with minor exceptions, commence on a day to be appointed by the Governor-in-Council.

Clause 3 defines the Principal Act.

Clause 4 is a formal provision that gives effect to the Schedule of amendments to the Principal Act.

Clause 5 is a savings and transitional provision which preserves the appointment of existing commissioners for the balance of their existing terms of appointment.

Schedule 1 (1) amends certain definitions to change the office of Chairman of the Prices Commission to that of Chairperson.

Schedule 1 (2) (a) and (b) enable the appointment of a full-time or part-time Chairperson of the Prices Commission (at present the Chairman is required to be a full-time commissioner).

Schedule 1 (2) (c) provides that a part-time commissioner may be appointed to another full-time statutory position.

Schedule 1 (3)-(7) are consequential amendments.

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

**5 Short title**

1. This Act may be cited as the "Prices Regulation (Amendment) Act 1986".

**Commencement**

2. (1) Sections 1 and 2 shall commence on the date of assent to this  
10 Act.

(2) Except as provided by subsection (1), this Act shall commence on such day as may be appointed by the Governor and notified by proclamation published in the Gazette.

**Principal Act**

15 3. The Prices Regulation Act 1948 is referred to in this Act as the Principal Act.

**Amendment of Act No. 26, 1948**

4. The Principal Act is amended in the manner set forth in Schedule 1.

**Savings and transitional provisions**

20 5. (1) A person who, immediately before the commencement of this Act, held office as a commissioner of the Prices Commission shall be deemed to have been duly appointed as a part-time commissioner and, in the case of the Chairman of that Commission, as Chairperson of that Commission.

(2) A person referred to in subsection (1) —

25 (a) shall be deemed to have been so appointed for the residue of the term of office for which the person was appointed; and

(b) is eligible for re-appointment (if otherwise qualified).

30 (3) Notwithstanding subsection (1), the Chairperson of the Prices Commission shall be deemed to have been appointed as a full-time commissioner instead of a part-time commissioner, pursuant to that subsection, if the Chairperson is not also appointed on the commencement

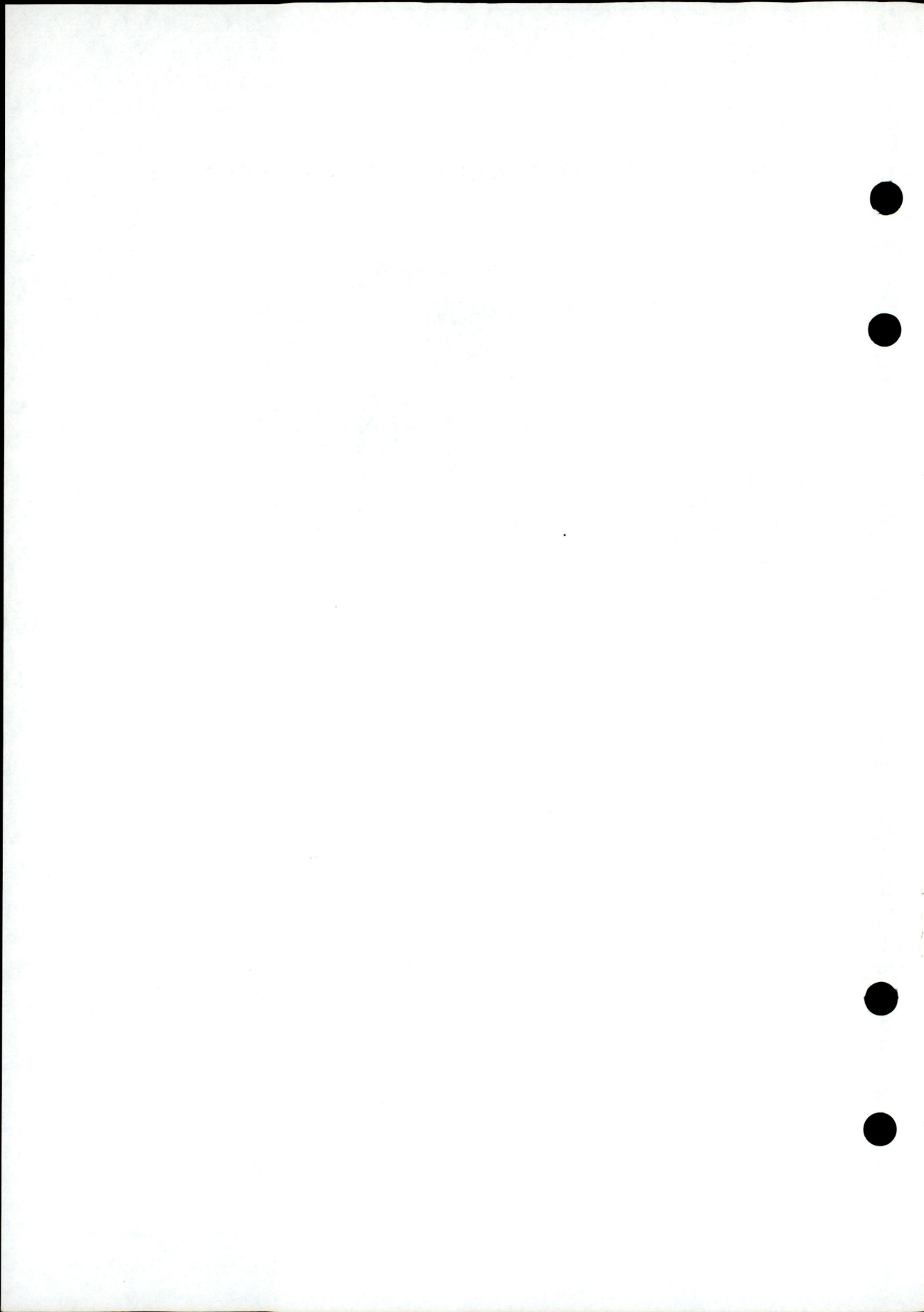

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

**Short title**

1. This Act may be cited as the "Prices Regulation (Amendment) Act 1986".

**Commencement**

2. (1) Sections 1 and 2 shall commence on the date of assent to this Act.

(2) Except as provided by subsection (1), this Act shall commence on such day as may be appointed by the Governor and notified by proclamation published in the Gazette.

**Principal Act**

3. The Prices Regulation Act 1948 is referred to in this Act as the Principal Act.

**Amendment of Act No. 26, 1948**

4. The Principal Act is amended in the manner set forth in Schedule 1.

**Savings and transitional provisions**

5. (1) A person who, immediately before the commencement of this Act, held office as a commissioner of the Prices Commission shall be deemed to have been duly appointed as a part-time commissioner and, in the case of the Chairman of that Commission, as Chairperson of that Commission.

(2) A person referred to in subsection (1) —

(a) shall be deemed to have been so appointed for the residue of the term of office for which the person was appointed; and
