PRICKLY-PEAR (AMENDMENT) BILL 1985

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Pastures Protection (Rates) Amendment Bill 1985.

The object of this Bill is to amend the Prickly-pear Act 1924 as a consequence of the enactment of the Pastures Protection (Rates) Amendment Bill 1985.

Clause 1 specifies the short title of the proposed Act.

Clause 2 provides that the proposed Act will, with minor exceptions, commence on the day appointed by the Governor-in-Council in respect of Schedule 1 (3) to the proposed Pastures Protection (Rates) Amendment Act 1985.

Clause 3 amends the Principal Act by substituting provisions relating to the making and levying of a special rate by pastures protection boards to defray expenses incurred in relation to the eradication of prickly-pear. It also applies certain sections of the Pastures Protection Act 1934, as proposed to be amended by the proposed Pastures Protection (Rates) Amendment Act 1985, to the special rate.

Clause 4 provides that nothing in the proposed Act shall affect the payment, collection or recovery of a special rate made and levied under the Principal Act by a pastures protection board before the commencement of the proposed Act.

An Act to amend the Prickly-pear Act 1924 consequent on and in connection with the enactment of the Pastures Protection (Rates) Amendment Act 1985; and for other purposes.

Prickly-pear (Amendment) 1985

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

5 Short title

1. This Act may be cited as the "Prickly-pear (Amendment) Act 1985".

Commencement

2. (1) Sections 1 and 2 shall commence on the date of assent to this Act.
- 10 (2) Except as provided by subsection (1), this Act shall commence on the day appointed and notified under section 2 (2) of the Pastures Protection (Rates) Amendment Act 1985 for the commencement of Schedule 1 (3) to that Act.

Amendment of Act No. 31, 1924

- 15 3. The Prickly-pear Act 1924 is amended by omitting section 24 (2) and by inserting instead the following subsections:

- 20 (2) Subject to subsection (2A), for the purpose of defraying the expenses incurred by it in the eradication of prickly-pear, a Pastures Protection Board may make and levy in any year a special rate on each occupier of land within the district of the Board who is liable to pay a general rate within the meaning of the Pastures Protection Act 1934.

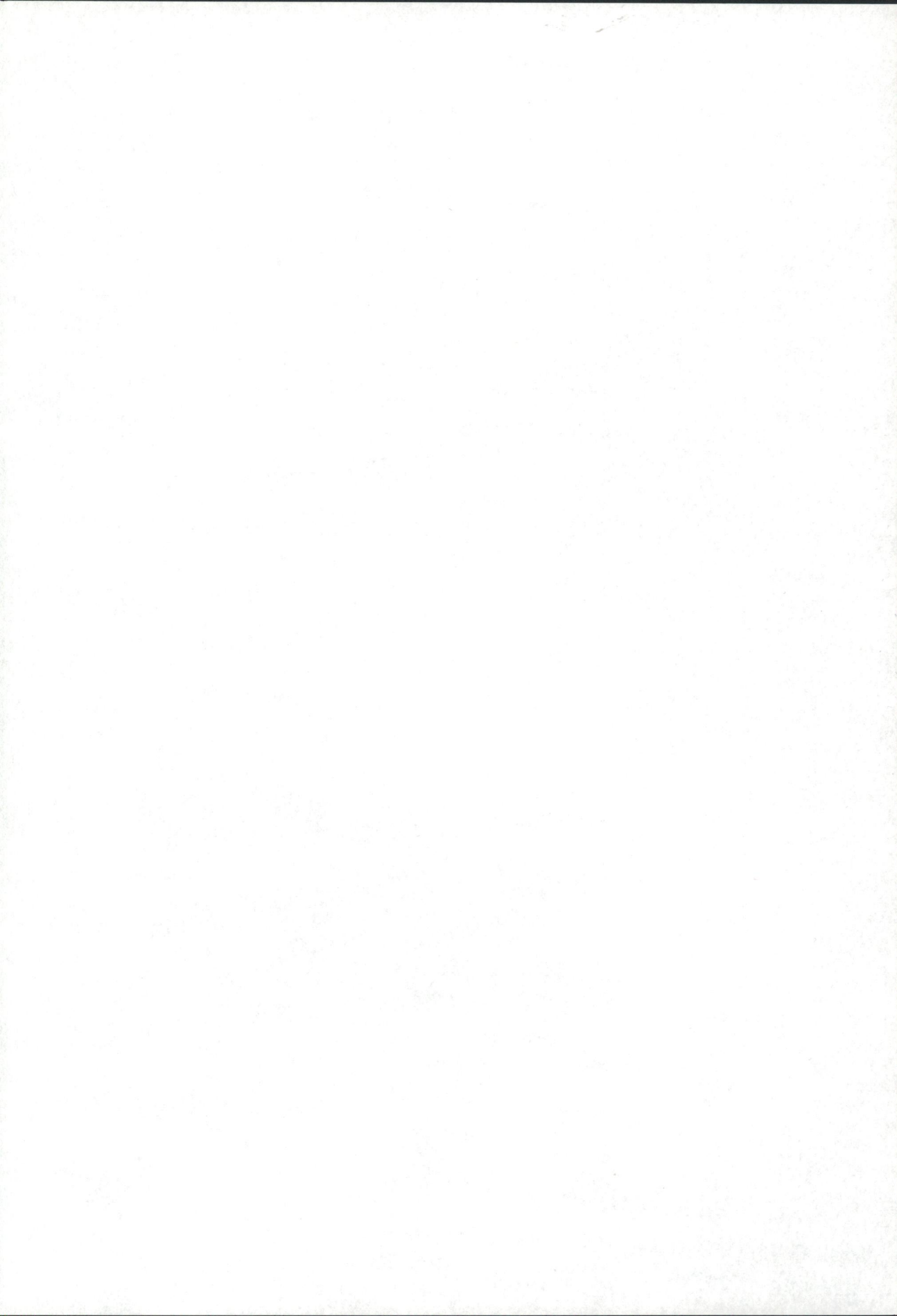
(2A) The Governor may by order published in the Gazette impose a maximum rate under this section.

- 25 (2B) The provisions of sections 31-33, 35, 37-39 and 40A of the Pastures Protection Act 1934 apply to a special rate made under this section in the same way as they apply to a rate made under that Act.

Act No. 174, 1985

An Act to amend the Prickly-pear Act 1924 consequent on and in connection with the enactment of the Pastures Protection (Rates) Amendment Act 1985; and for other purposes. [Assented to, 3rd December, 1985.]

Prickly-pear (Amendment) 1985

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

Short title

1. This Act may be cited as the "Prickly-pear (Amendment) Act 1985".

Commencement

2. (1) Sections 1 and 2 shall commence on the date of assent to this Act.

(2) Except as provided by subsection (1), this Act shall commence on the day appointed and notified under section 2 (2) of the Pastures Protection (Rates) Amendment Act 1985 for the commencement of Schedule 1 (3) to that Act.

Amendment of Act No. 31, 1924

3. The Prickly-pear Act 1924 is amended by omitting section 24 (2) and by inserting instead the following subsections:

(2) Subject to subsection (2A), for the purpose of defraying the expenses incurred by it in the eradication of prickly-pear, a Pastures Protection Board may make and levy in any year a special rate on each occupier of land within the district of the Board who is liable to pay a general rate within the meaning of the Pastures Protection Act 1934.

(2A) The Governor may by order published in the Gazette impose a maximum rate under this section.

(2B) The provisions of sections 31-33, 35, 37-39 and 40A of the Pastures Protection Act 1934 apply to a special rate made under this section in the same way as they apply to a rate made under that Act.

Prickly-pear (Amendment) 1985

Transitional

4. Nothing in this Act shall affect the payment, collection or recovery of a rate made and levied under section 24 of the Prickly-pear Act 1924 by a board within the meaning of the Pastures Protection Act 1934 before the commencement of this Act.
