EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Mental Health (Amendment) Bill 1986.

The object of this Bill is to correct a cross-reference in section 18 of the Protected Estates Act 1983 to certain provisions of the Mental Health Act 1983.

Clause 1 specifies the short title of the proposed Act.

Clause 2 effects the correction referred to above.

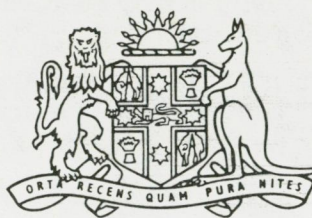

Protected Estates (Amendment) 1986

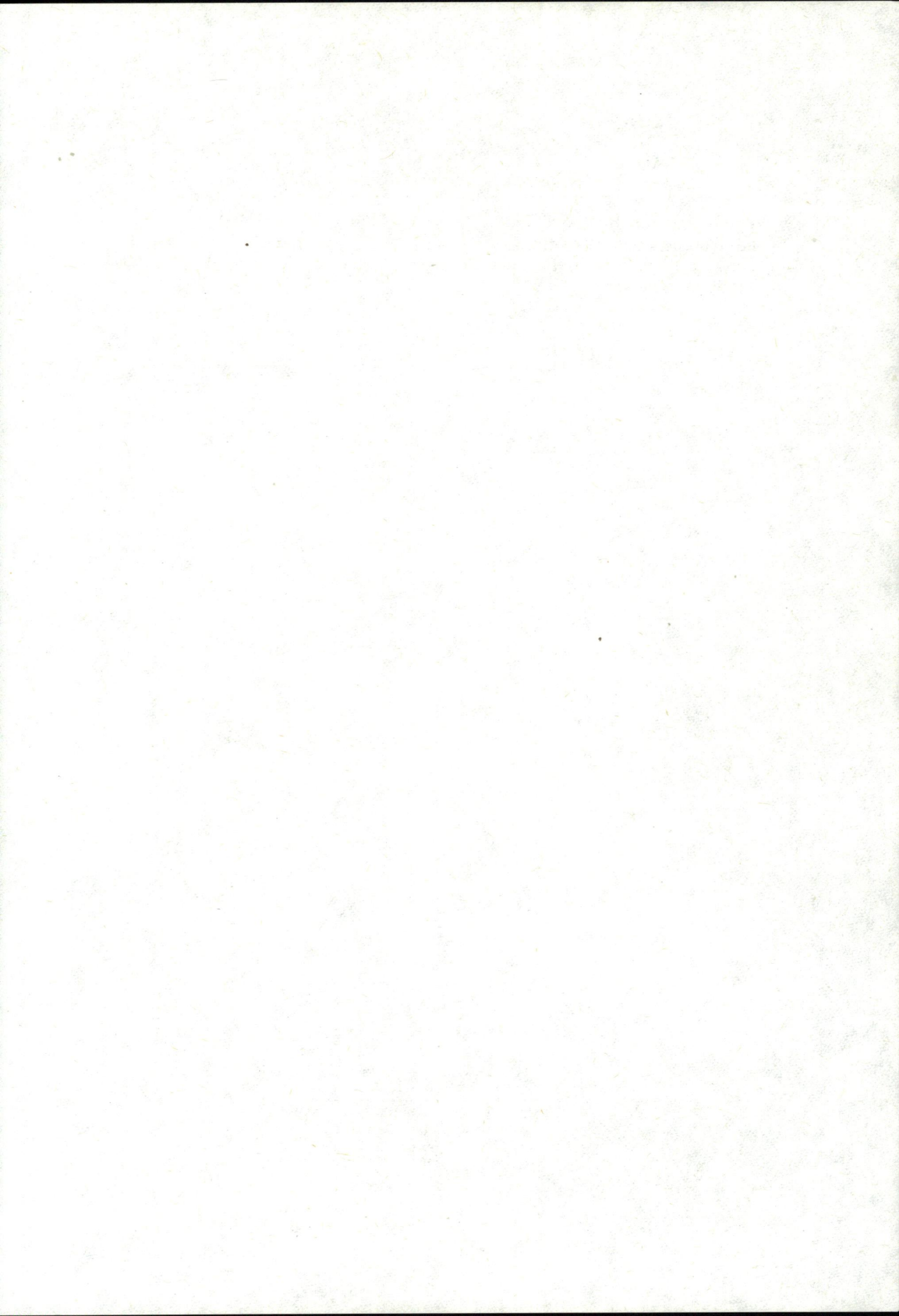
BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

5 Short title

1. This Act may be cited as the "Protected Estates (Amendment) Act 1986".

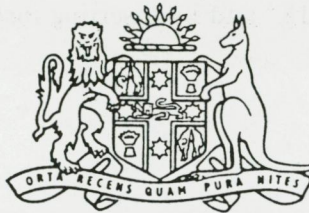
