**PUBLIC FINANCE AND AUDIT (HOUSING)
AMENDMENT BILL 1985**

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Housing Bill 1985.

The object of this Bill is to amend the Public Finance and Audit Act 1983 in consequence of the enactment of the proposed Housing Act 1985.

Clause 1 specifies the short title of the proposed Act.

Clause 2 provides that the proposed Act will, with minor exceptions, commence on 1 January 1986.

Clause 3 (1) amends Schedule 2 to the Principal Act so as to insert a reference to the New South Wales Land and Housing Corporation which is proposed to be constituted by the Housing Act 1985.

Clause 3 (2) amends Schedule 2 to the Principal Act so as to omit references to the Housing Commission and the Land Commission which are to be abolished by the Housing Act 1985.

Public Finance and Audit (Housing) Amendment 1985

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

5 Short title

1. This Act may be cited as the "Public Finance and Audit (Housing) Amendment Act 1985".

Commencement

2. (1) Sections 1 and 2 shall commence on the date of assent to this
10 Act.

(2) Except as provided by subsection (1), this Act shall commence on 1 January 1986.

Amendment of Act No. 152, 1983

3. (1) The Public Finance and Audit Act 1983 is amended by inserting
15 in Schedule 2 in alphabetical order the words "New South Wales Land and Housing Corporation."

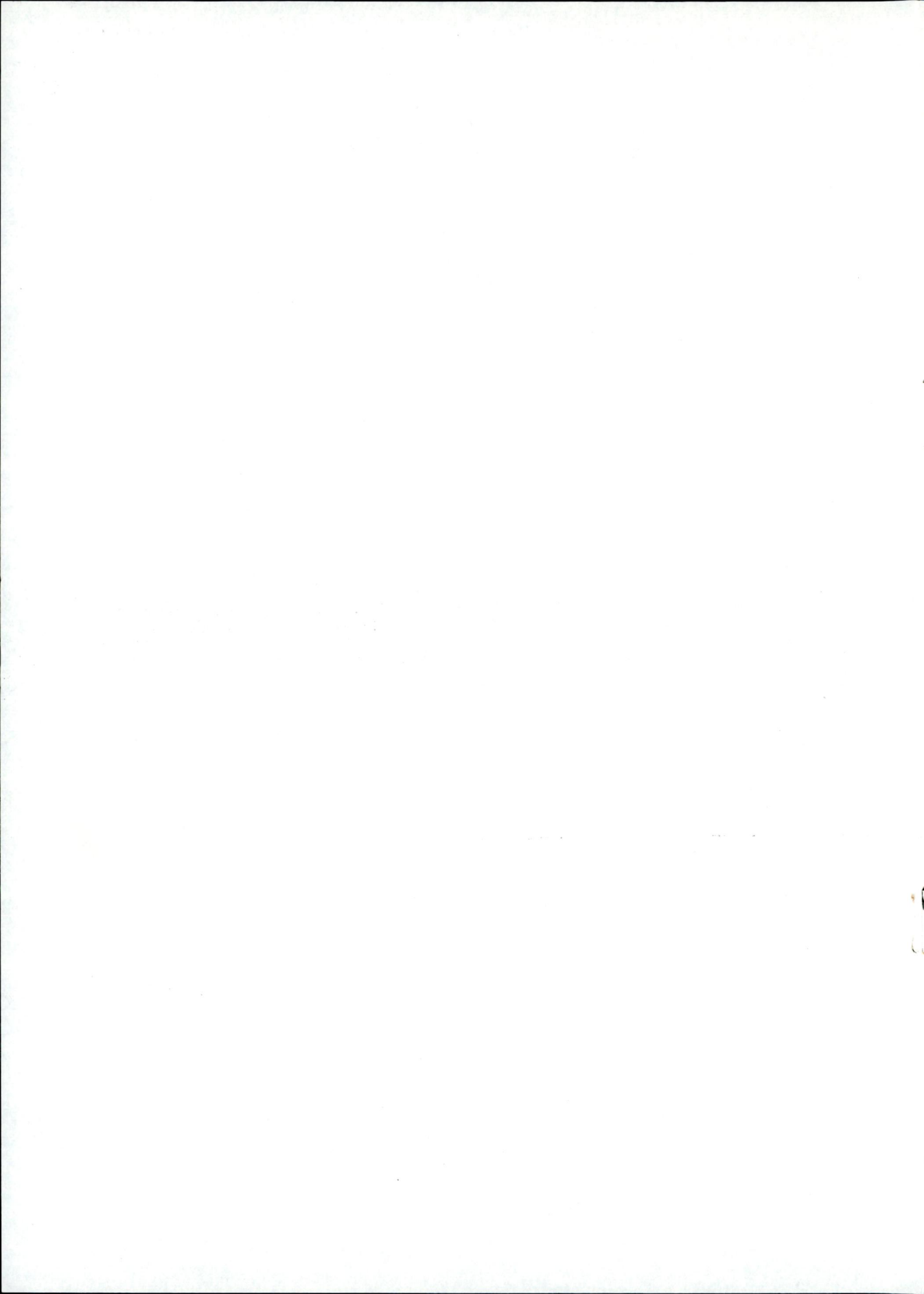
(2) The Public Finance and Audit Act 1983 is further amended by omitting from Schedule 2 the following words:

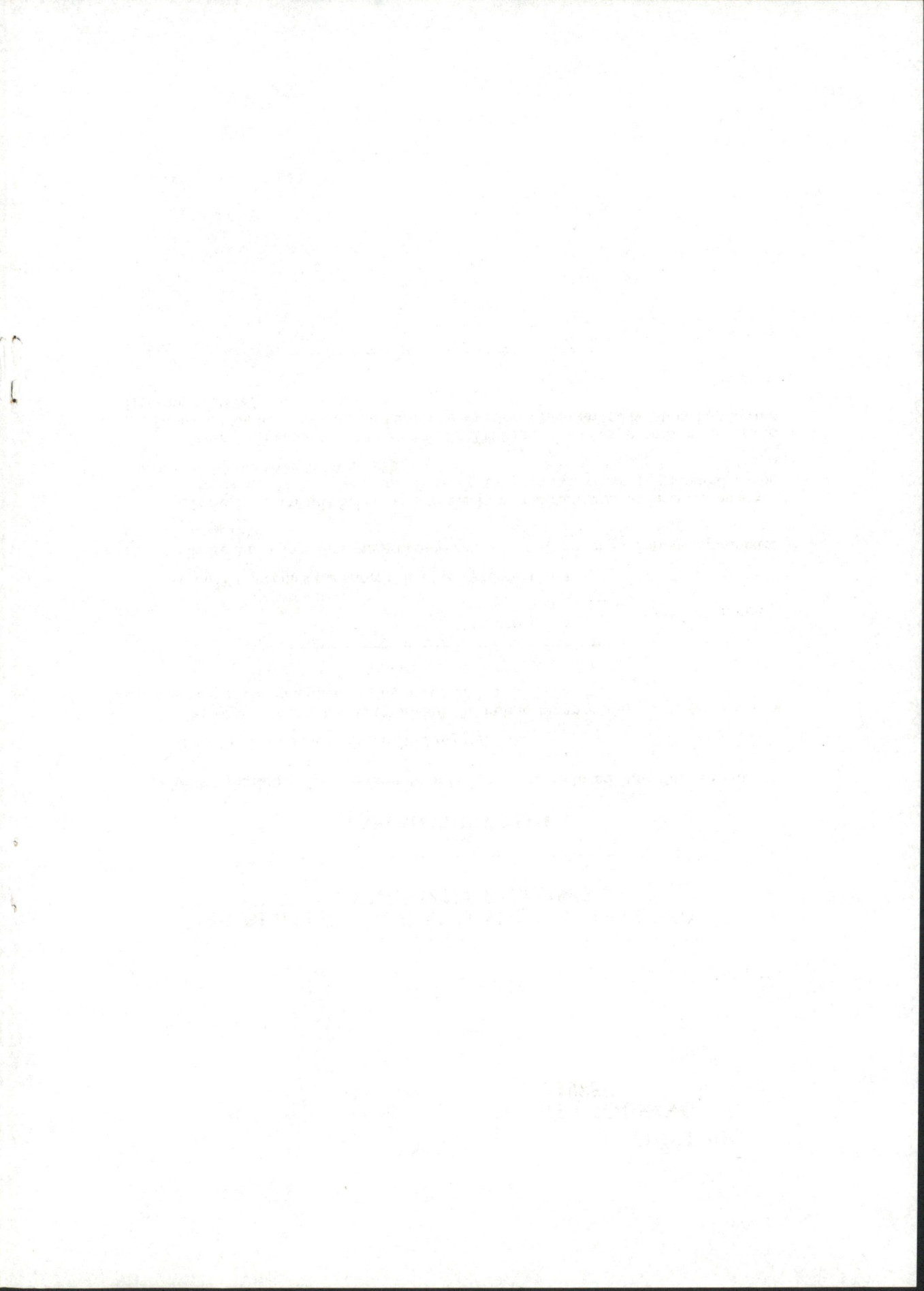

Public Finance and Audit (Housing) Amendment 1985
