**PUBLIC FINANCE AND AUDIT (SYDNEY MARKET
AUTHORITY) AMENDMENT BILL 1985**

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Sydney Farm Produce Market Authority (Amendment) Bill 1985.

The object of this Bill is to amend Schedule 2 to the Public Finance and Audit Act 1983, replacing the reference to the Sydney Farm Produce Market Authority with a reference to the Sydney Market Authority.

Clause 1 specifies the short title of the proposed Act.

Clause 2 provides that the proposed Act will, with minor exceptions, commence on the day on which the Sydney Market Authority is constituted by force of the Sydney Farm Produce Market Authority (Amendment) Act 1985 (being the day appointed and notified under section 2 (2) of that Act).

Clause 3 effects the amendment described above.

Public Finance and Audit (Sydney Market Authority) Amendment 1985

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

5 Short title

1. This Act may be cited as the "Public Finance and Audit (Sydney Market Authority) Amendment Act 1985".

Commencement

2. (1) Sections 1 and 2 shall commence on the date of assent to this Act.

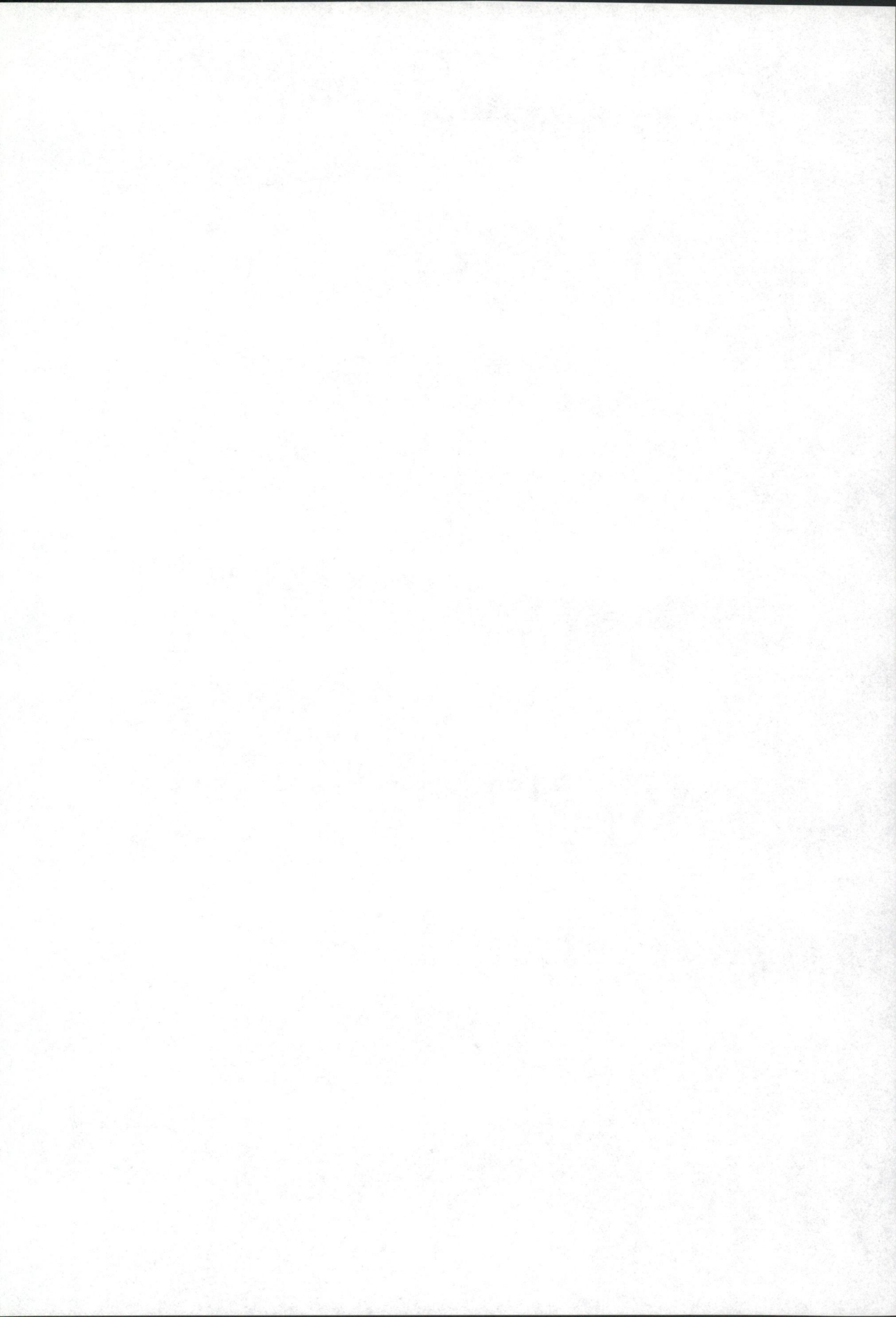

Public Finance and Audit (Sydney Market Authority) Amendment 1985

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

Short title

1. This Act may be cited as the "Public Finance and Audit (Sydney Market Authority) Amendment Act 1985".

Commencement

2. (1) Sections 1 and 2 shall commence on the date of assent to this Act.

(2) Except as provided by subsection (1), this Act shall commence on the day appointed and notified under section 2 (2) of the Sydney Farm Produce Market Authority (Amendment) Act 1985.
