EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Registration of Interests in Goods Bill 1986.


The object of this Bill is to amend the Sale of Goods Act 1923 so that the provision of that Act preventing a purchaser of goods from obtaining a better title than the vendor is excluded where the proposed Registration of Interests in Goods Act 1986 otherwise provides.

Clause 1 specifies the short title of the proposed Act.

Clause 2 provides for the commencement of the proposed Act at the same time as that of the proposed Registration of Interests in Goods Act 1986.

Clause 3 amends section 26 of the Sale of Goods Act 1923 by including among the exceptions to its operation the provisions of the proposed Registration of Interests in Goods Act 1986.

A BILL FOR

An Act to amend the Sale of Goods Act 1923 as a consequence of the enactment of the Registration of Interests in Goods Act 1986.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

5 Short title

1. This Act may be cited as the "Sale of Goods (Registrable Interests) Amendment Act 1986".

Commencement

- 2. (1) Sections 1 and 2 shall commence on the date of assent to this 10 Act.
 - (2) Except as provided by subsection (1), this Act shall commence on the day appointed and notified under section 2 (2) of the Registration of Interests in Goods Act 1986.


