EXPLANATORY NOTE


This Bill is cognate with the Exhibited Animals Protection Bill 1986.

The object of this Bill is to amend the Search Warrants Act 1985 so as to apply that Act to search warrants issued under section 42 of the proposed Exhibited Animals Protection Act 1986.

Clause 1 specifies the short title of the proposed Act.

Clause 2 provides that the amendment made by the proposed Act will commence on the day appointed for the commencement of section 42 of the proposed Exhibited Animals Protection Act 1986.

Clause 3 adds to the definition of "search warrant" in section 10 of the Search Warrants Act 1985 a reference to a search warrant issued under the proposed Exhibited Animals Protection Act 1986.

A BILL FOR

An Act to amend the Search Warrants Act 1985 as a consequence of the enactment of the Exhibited Animals Protection Act 1986.

1. This Act may be cited as the "Search Warrants (Exhibited Animals) Amendment Act 1986".




