SEARCH WARRANTS (GAS) AMENDMENT BILL 1986

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Gas Bill 1986.

The object of this Bill is to amend the Search Warrants Act 1985-

- (a) to add to the list of search warrants to which Part III of that Act applies search warrants issued under the proposed Gas Act 1986; and
- (b) to omit from that list search warrants issued under the Gas and Electricity Act 1935.

Clause 1 specifies the short title of the proposed Act.

Clause 2 provides that the proposed Act will, with minor exceptions, commence on the commencement of the proposed Gas and Electricity (Gas Repeal) Amendment Act 1986.

Clause 3 is a formal provision that gives effect to the Schedule of amendments to the Principal Act.

Clause 4 is a saving provision which continues the operation of Part III of the Search Warrants Act 1985 to a search warrant issued under the Gas and Electricity Act 1935 before the commencement of the proposed Act.

Schedule 1 (1) adds to the definition of "search warrant" in section 10 of the Search Warrants Act 1985 a reference to a search warrant issued under the Gas Act 1986.

Schedule 1 (2) deletes from that definition a reference to a search warrant issued under the Gas and Electricity Act 1935, the relevant provision of which will be repealed by the proposed Gas and Electricity (Gas Repeal) Amendment Act 1986.




