SOCCER FOOTBALL POOLS (AMENDMENT) BILL 1986

NEW SOUTH WALES



EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

The object of this Bill is to amend the Soccer Football Pools Act 1975 so as—

- (a) to vary the amount of duty payable to the government by a licensee in respect of soccer football pools subscriptions and to enable an alternative duty to be prescribed by the Governor-in-Council; and
- (b) to allow the Minister to extend the period for which a licence to promote, conduct or operate soccer football pools is in force.

Clause 1 specifies the short title of the proposed Act.

Clause 2 provides for the commencement of the proposed Act. The provisions relating to the amount of duty payable in respect of subscriptions are given force from 20 April 1986 to validate the rate at which duty has been paid since that date by agreement between the licensee and the government.

Clause 3 is a formal provision which gives effect to the Schedule of amendments.

Schedule 1 (1) amends section 2 of the Principal Act to insert a definition of "financial year", meaning a year commencing on 1 July.

Schedule 1 (2) (a) amends section 6 of the Principal Act in consequence of the amendment made by Schedule 1 (3).

Schedule 1 (2) (b) amends section 6 of the Principal Act so as to allow the Minister to extend the duration of a licence to promote, conduct or operate soccer football pools for a period not exceeding (or periods in the aggregate not exceeding) 10 years.

Schedule 1 (3) amends section 14 of the Principal Act so as to vary the amount of duty payable to the Minister by the licensee in respect of soccer football pools subscriptions. Provision is also made for duty to be prescribed by the Governor-in-Council to replace the duty specified in the Principal Act.

Schedule 1 (4) inserts proposed section 14A into the Principal Act which provides for the payment of additional duty under the Principal Act in respect of certain soccer football pools conducted in the first financial year commencing on or after 1 July 1986 in which subscriptions to soccer football pools reach \$104,000,000.

A BILL FOR

An Act to amend the Soccer Football Pools Act 1975 with respect to the duty payable under that Act and the duration of licences.

Soccer Football Pools (Amendment) 1986

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

5 Short title

1. This Act may be cited as the "Soccer Football Pools (Amendment) Act 1986".

Commencement

2. (1) Except as provided by subsection (2), this Act shall commence
10 on the date of assent to this Act.

(2) Schedule 1 (3), and section 3 in its application to that provision, shall be deemed to have commenced on 20 April 1986.

10 S is the amount of subscriptions received in New South Wales in respect of the pool; and

N is the amount of subscriptions received in New South Wales and elsewhere in respect of the pool; and

- 15 (c) if provision is made by the regulations for the payment of duty, pay duty to the Minister in accordance with the regulations.

(c) Section 14 (3)—

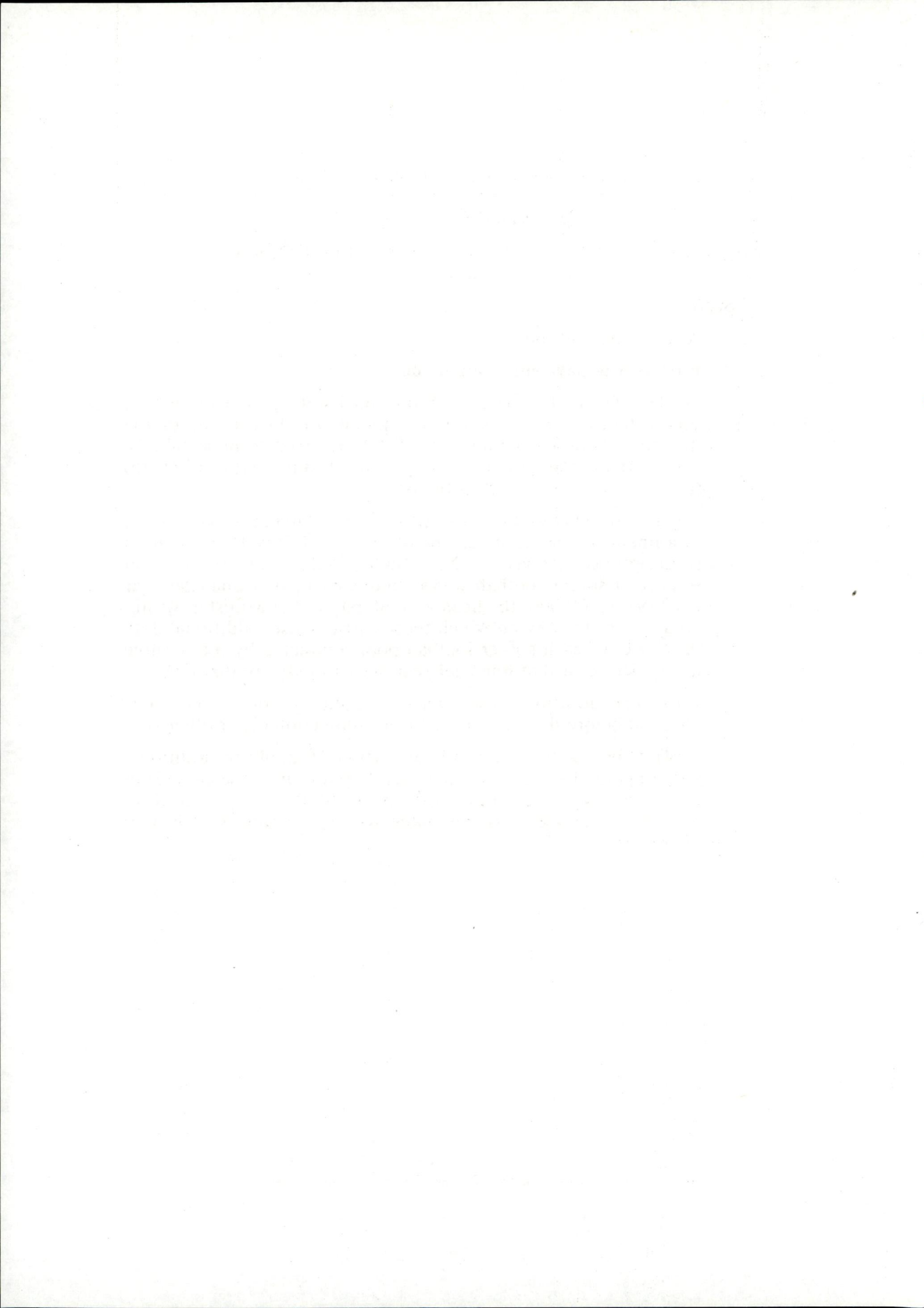
10 (2) If at the close of entries to a soccer football pool conducted in a financial year commencing on or after 1 July 1986 the total subscriptions received in New South Wales and elsewhere in respect of soccer football pools conducted in that financial year reach \$104,000,000, the licensee shall pay to the Minister, within
15 7 days after the day on which those entries close, additional duty in respect of each soccer football pool conducted by the licensee in the period of that financial year occurring before that day.

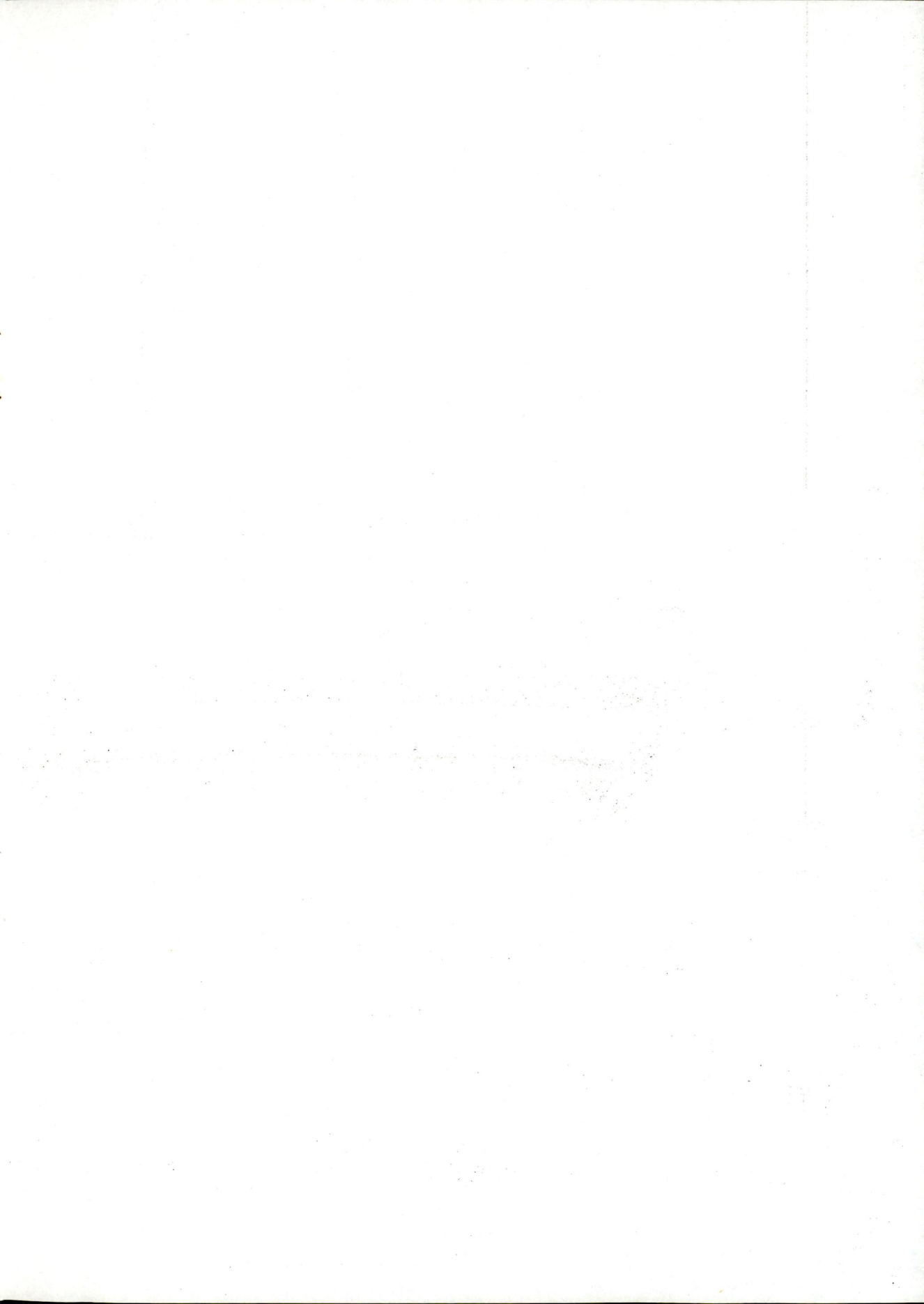
(3) The additional duty may be paid out of subscriptions received before the day referred to in subsection (2) or otherwise.

20 (4) Subsections (3) and (4) of section 16 apply to additional duty unpaid after the 7-day period referred to in subsection (2) in the same way as they apply to the payment of duty referred to in section 16 (1) which is not made within the time specified in section 16 (1).

(3) The additional duty may be paid out of subscriptions received before the day referred to in subsection (2) or otherwise.

(4) Subsections (3) and (4) of section 16 apply to additional duty unpaid after the 7-day period referred to in subsection (2) in the same way as they apply to the payment of duty referred to in section 16 (1) which is not made within the time specified in section 16 (1).
