### **EXPLANATORY NOTE**

#### (This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Pay-roll Tax (Amendment) Bill 1986.

The object of this Bill is to amend the Stamp Duties Act 1920 so as to provide that the Chief Commissioner of Stamp Duties may perform the functions of a State taxation officer under Part IIIA of the Taxation Administration Act 1953 of the Commonwealth, which provides for the exchange of information and other co-operation between Commonwealth and State taxation authorities in the enforcement of taxation laws.

Clause 1 specifies the short title of the proposed Act.

Clause 2 effects the amendment described above.


