STATUTE LAW (MISCELLANEOUS AMENDMENTS) BILL, 1984

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

The objects of this Bill are—

- (a) to repeal certain Acts that are obsolete or no longer of practical utility (Schedule 1);
- (b) to make amendments to various Acts (Schedules 2-15);
- (c) to amend certain other Acts for the purpose of effecting statute law revision (Schedule 16); and
- (d) to make other provisions of a minor, consequential or ancillary nature.

The Bill contains the following Schedules:-

Schedule 1 repeals certain Acts that are obsolete or no longer of practical utility.

Schedule 2 amends the Baptist Churches of New South Wales Property Trust Act, 1984, so as to require certain directions or resolutions of a Baptist Church or District Association to be passed at a meeting by a special majority of the votes of such of the persons entitled to vote as are actually present and vote. At present, the Act requires such a direction or resolution to be passed at a meeting by a majority of a proportion of all the persons entitled to vote, whether or not they are actually present or vote.

Schedule 3 amends the Co-operation Act, 1923, so as to enable the Minister to determine the period of office of members (other than the Registrar) of the Advisory Committee established under that Act without the need for prescribing that period. The proposed amendment will bring the Act into line with the Friendly Societies Act, 1912, the Permanent Building Societies Act, 1967, and the Credit Union Act, 1969, in this respect.

Schedule 4 amends—

- (a) the Credit Act, 1984, so as-
 - (i) to change the reference to "goods mortgage" in section 30 (2) of the Act to "mortgage", since the expression "goods mortgage" is not otherwise used in the credit legislation; and
 - (ii) to provide that certain contracts of insurance relating to regulated contracts or regulated mortgages (within the meaning of the Act) are not rendered "voidable" in certain circumstances, thus bringing the language into line in this respect with recent amendments to the Insurance Act, 1902;
- (b) the Credit (Administration) Act, 1984, so as-
 - (i) to insert a definition of "Chairman" into the Act; and
 - (ii) to make it clear that a person (being a person carrying on a business, referred to in section 7 (2) of the Act, of providing credit otherwise than under a regulated contract or of collecting money from persons whose licences are no longer in force) who is exempted from the requirement to be licensed as a credit provider is not required to be registered under section 7 (4) of the Act as a credit provider; and
- (c) the Credit (Finance Brokers) Act, 1984, so as to omit references to commercial vehicles and farm machinery, as they are already covered by other provisions.

Schedule 5 amends the Education Commission Act, 1980, so as-

- (a) to apply certain provisions of the Act to persons appointed by either the Director-General of Education or the Director-General of Technical and Further Education under section 50 (1) or 58 (1) of the Act, in the same way as they apply to other persons appointed under section 50 or 58 of the Act (Schedule 5 (1)); and
- (b) to insert a provision which allows the Director-General of Education or the Director-General of Technical and Further Education to make use of the services of staff of either Teaching Service or of the Public Service (Schedule 5 (2)—proposed section 71A).

Schedule 6 amends the Forestry Act, 1916, so as to increase from \$50,000 to \$150,000 the amount that the Forestry Commission may expend on any work without having to obtain the particular approval of the Minister.

Schedule 7 amends the Interpretation Act, 1897, so as—

- (a) to define "Local Court", "District Court" and "Supreme Court" (Schedule 7 (1));
- (b) to enable the expression "commencement" of an Act or instrument to be used even though the Act or instrument concerned may provide that some provisions are to commence at different times (Schedule 7 (2)—proposed section 36A); and

- (c) to provide that-
 - (i) where a penalty in an Act or instrument for an offence is increased, the increased penalty only extends to offences committed after the increase takes effect; and
 - (ii) where a penalty in an Act or instrument for an offence is reduced, the reduced penalty extends to offences committed before the reduction takes effect, but without affecting penalties imposed before the reduction.

(Schedule 7 (3)—proposed section 45).

Schedule 8 amends the Justices Act, 1902, so as—

- (a) to enable an officer or employee of a pastures protection board—
 - (i) to serve a summons in respect of an information for an offence punishable summarily before a Justice or Justices by post (Schedule 8 (2)); and
 - (ii) to take advantage of the provisions of section 75B of that Act (ex parte procedure for certain offences) (Schedule 8 (3)); and
- (b) to effect statute law revision (Schedule 8 (1), (4)).

Schedule 9 amends the definition of "prohibited purpose" in the Lie Detectors Act, 1983, so as to remove any doubt that a reference to an offence punishable by imprisonment may not include a reference to an offence punishable by penal servitude.

Schedule 10 amends the Optometrists Act, 1930, to remove the \$4 limit on the prescribed roll fee for registered optometrists.

Schedule 11 amends the Public Service Act, 1979, so as-

- (a) to insert a provision which allows a Department Head to make use of the services of the staff of a Teaching Service (Schedule 11 (3)—proposed section 112A); and
- (b) to effect statute law revision (Schedule 11 (1), (2)).

Schedule 12 amends the Registered Clubs Act, 1976, so as—

- (a) to provide a penalty of \$200 for a contravention of section 67 (6) of that Act relating to a failure to supply requested information to certain persons including members of the police force (Schedule 12 (6)); and
- (b) to effect statute law revision (Schedule 12 (1)–(5)).

Schedule 13 amends the Reprints Act, 1972, so as to enable the amendment of Acts or statutory instruments by removing matter in columns or tabular format and replacing that matter in another format and by removing "arrangement" clauses (which are now generally replaced by Tables of Provisions prefacing Principal Bills and reprints of Principal Acts).

Schedule 14 amends The Sir Moses Montefiore Jewish Home Act, 1927, so as to change the financial year of the Body Corporate constituted under that Act.

Schedule 15 amends the Unitarian Church Act, 1927, so as-

- (a) to enable the congregation, with the approval of the Minister administering the Charitable Collections Act, 1934, to determine the maximum value of property which is not to be treated as trust property (Schedule 15 (1) (a));
- (b) to reduce the minimum age for membership of the congregation to 18 years (Schedule 15 (2));
- (c) to omit the provision that requires a copy of the register of members of the congregation to be delivered to the Under Secretary for the Department of the Chief Secretary of the State of New South Wales (Schedule 15 (3) (a));
- (d) to remove the requirement that a fee is to be paid by a person claiming to be entitled to be registered as a member of the congregation or to remain registered as such (Schedule 15 (3) (b));
- (e) to provide that a decision of the committee of the congregation as to whether a person is entitled to be entered in the register of members of the congregation or remain in the register shall be final (Schedule 15 (3) (c));
- (f) to provide that one-fifth of the number of members of the congregation is sufficient for a quorum at general meetings of the congregation if the existing requirement of 15 members is not met (Schedule 15 (4) (a));
- (g) to remove the requirement that a person cannot vote on the election or appointment of a trustee unless the person has been a member of the congregation for at least 2 years (Schedule 15 (4) (b));
- (h) to allow buildings on Unitarian Trust property to be hired out for more than 7 days (Schedule 15 (5));
- (i) to enable any Unitarian Trust property to be mortgaged, charged or encumbered for a sum not exceeding one-quarter of the current market value of the property (Schedule 15 (6));
- (j) to provide that a special resolution of the congregation may be passed by 25 members of the congregation or, where less than 50 members are included in the register of members of the congregation, 15 members of the congregation voting at a duly convened meeting (Schedule 15 (7)); and
- (k) to effect statute law revision (Schedule 15 (1) (b)).

Schedule 16 amends certain other Acts for the purpose of effecting statute law revision.

Schedule 17 contains savings, transitional, validatory and other matters.

A BILL FOR

An Act to repeal certain Acts and amend certain other Acts in various respects and for the purpose of effecting statute law revision; and to make certain savings and validate certain matters.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

5 Short title.

1. This Act may be cited as the "Statute Law (Miscellaneous Amendments) Act, 1984",

Commencement.

- 2. (1) Except as provided by this section, this Act shall commence on 10 the date of assent to this Act.
 - (2) Schedules 14 and 15, and section 5 in its application to those Schedules, shall commence on such day or days as may be appointed by the Governor in respect thereof and as may be notified by proclamation published in the Gazette.
- 15 (3) So much of Schedule 16 as relates to the Totalizator (Off-course Betting) Act, 1964, and section 5 in its application thereto, shall, if the date of assent to this Act is earlier than the day appointed and notified under section 2 (2) of the Tourism Commission Act, 1984, commence on the day so appointed and notified.





Act No. 153, 1984.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

SAVINGS AND OTHER PROVISIONS.

Private Acts.

1. A Private Act does not, by reason only of its being amended by this Act, become a Public Act.

Validation of matters under Baptist Churches of New South Wales Property Trust Act, 1984.

- 2. Any direction-
 - (a) which was given on or after 14th September, 1984, by a congregation or District Association, within the meaning of the Baptist Churches of New South Wales Property Trust Act, 1984;
 - (b) which purports to have been given, in accordance with the provisions of section 42 or 43 of that Act, for the purposes of that Act; and
 - (c) which could have been given in accordance with those provisions only if that Act, as amended by this Act. had been in force when the direction was given,

is hereby validated.

SAVINGS AND OTHER PROVISIONS—continued.

Validation of certain regulations under Optometrists Act, 1930.

3. Any regulation purporting to have been made under the Optometrists Act, 1930, before the date of assent to this Act shall, if it was not validly made, be, on and from that date, deemed to have been validly made and to be as valid and effectual as it would have been if the amendment made by section 5 and Schedule 10 had been in force when it purported to be made.

Transitional provisions relating to The Sir Moses Montefiore Jewish Home Act, 1927.

- 4. (1) Expressions used in this clause have the same meanings as in The Sir Moses Montefiore Jewish Home Act, 1927.
- (2) Notwithstanding section 20 of The Sir Moses Montefiore Jewish Home Act. 1927, as amended by this Act, at the first annual general meeting of the Body Corporate held after the commencement of Schedule 14, the Board of Management may lay before the members of the Body Corporate present at the meeting a statement of the income and expenditure for the period of 6 months or 18 months ending on 30th June next preceding the meeting, whichever it thinks appropriate.

Validation of certain matters relating to Noxious Insects Act, 1934.

- 5. Any act, matter or thing—
 - (a) which was done on or after 28th November, 1979, and before the amendment, by this Act, of the Noxious Insects Act, 1934, by the pastures protection boards specified by proclamation published in the Gazette under section 10 (1) of that Act; and
 - (b) which could lawfully have been done only if that Act, as amended by this Act, had been in force when the act, matter or thing was done,

is hereby validated.

Repeal of certain Acts by Registration of Births, Deaths and Marriages Act, 1973.

6. Each Act specified in Schedule 1 to the Registration of Births. Deaths and Marriages Act, 1973, is, to the extent specified opposite that Act in the Column headed "Extent of repeal", repealed and shall be deemed to have been so repealed on 1st January, 1974.

Effect of amendment of amending provisions.

7. An amendment made by Schedule 16 to an amending provision (as defined by the Reprints Act, 1972) contained in an Act shall, if the amending provision has commenced before the date of assent to this Act, be deemed to have taken effect as from the commencement of the amending provision.

References to bodies in certain Acts amended by this Act.

- 8. (1) A reference in section 16 (1) of the Balranald Irrigation Act, 1902, or section 17 of the Wentworth Irrigation Act to the "Trust" shall, as from the coming into existence of the Water Resources Commission, be deemed to have been a reference to that Commission.
- (2) A reference in section 20 (1) (b) of the Prices Regulation Act, 1948, to the "Commissioner" shall, as from the coming into existence of the Prices Commission, be deemed to have been a reference to that Commission.

Regulations.

- 9. (1) The Governor may make regulations containing other provisions of a savings or transitional nature consequent on the enactment of this Act.
- (2) A provision made under subclause (1) may take effect as from the date of assent to this Act or a later date.
- (3) To the extent to which a provision referred to in subclause (1) takes effect from a date that is earlier than the date of its publication in the Gazette, the provision does not operate so as—
 - (a) to affect, in a manner prejudicial to any person (other than the State or a public authority), the rights of that person existing before the date of its publication therein; or
 - (b) to impose liabilities on any person (other than the State or a public authority) in respect of anything done or omitted to be done before the date of its publication therein.

(4) A provision made under subclause (1) shall, if the regulations expressly so provide, have effect notwithstanding the foregoing clauses of this Schedule.
