**EXPLANATORY NOTE**

**(This Explanatory Note relates to this Bill as introduced into Parliament)**

This Bill is cognate with the Environmental Planning and Assessment (Amendment) Bill 1985.

The object of this Bill is to amend Part 1 of Schedule 2 to the Statutory and Other Offices Remuneration Act 1975 to provide for the remuneration of the Chairman and Deputy Chairman of Commissioners of Inquiry appointed under the Environmental Planning and Assessment Act 1979.

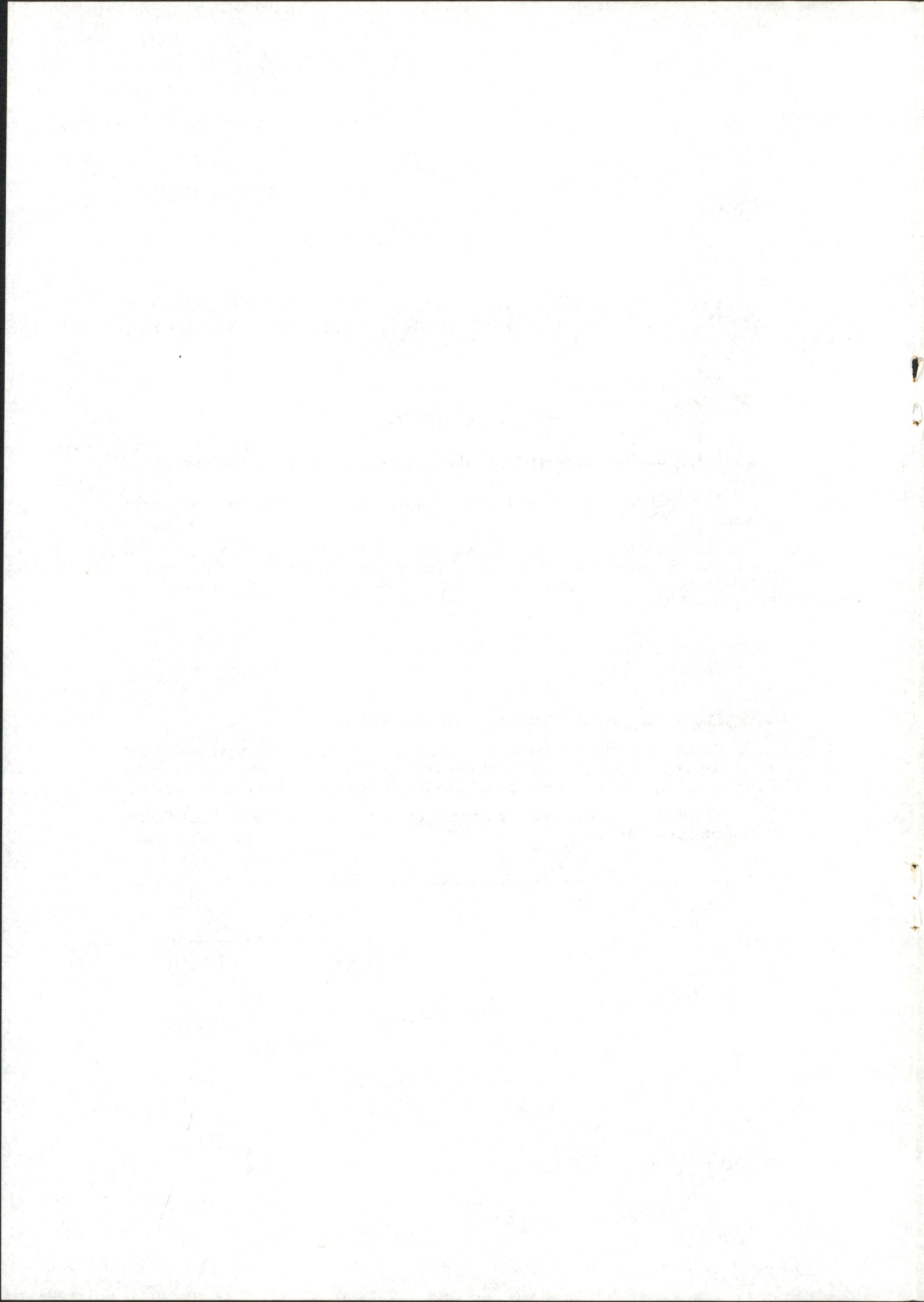

Clause 1 specifies the short title of the proposed Act.

Clause 2 provides that the proposed Act will, with minor exceptions, commence on the day appointed and notified under section 2 (3) of the proposed Environmental Planning and Assessment (Amendment) Act 1985 in respect of Schedule 2 to that Act.

Clause 3 effects the requisite amendment to the Statutory and Other Offices Remuneration Act 1975.

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

**5 Short title**

1. This Act may be cited as the "Statutory and Other Offices Remuneration (Commissioners of Inquiry) Amendment Act 1985".

**Commencement**

2. (1) Except as provided by subsection (2), this Act shall commence  
10 on the date of assent to this Act.

(2) Section 3 shall commence on the day appointed and notified under section 2 (3) of the Environmental Planning and Assessment (Amendment) Act 1985 in respect of Schedule 2 to that Act.

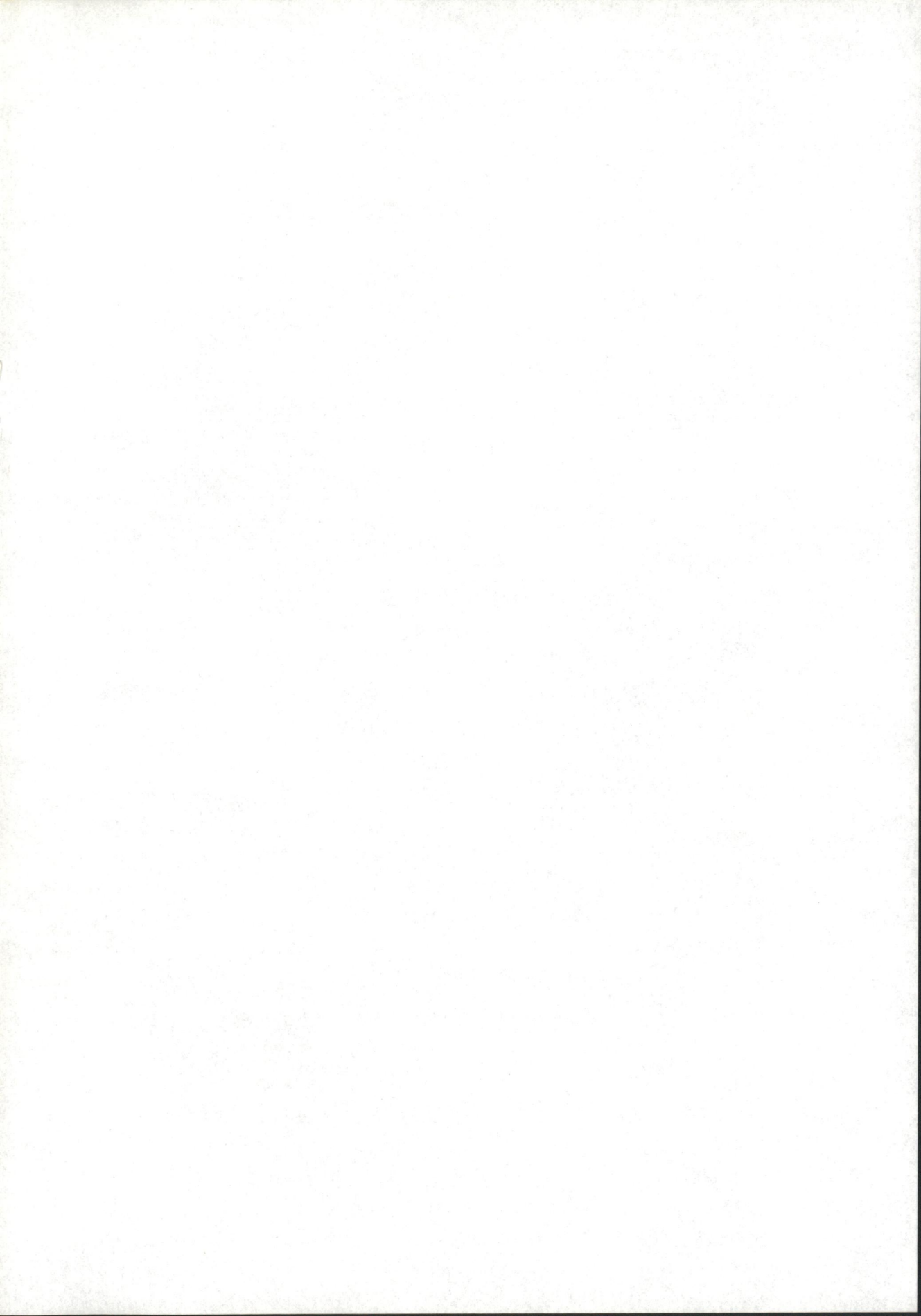
