EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the New South Wales Investment Corporation Bill 1986.

The object of this Bill is to amend the Statutory and Other Offices Remuneration Act 1975 in consequence of the enactment of the New South Wales Investment Corporation Bill 1986, so as to apply the provisions of that Act to the managing director of the New South Wales Investment Corporation.

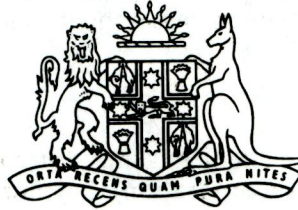

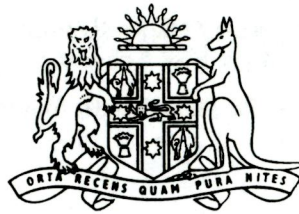
