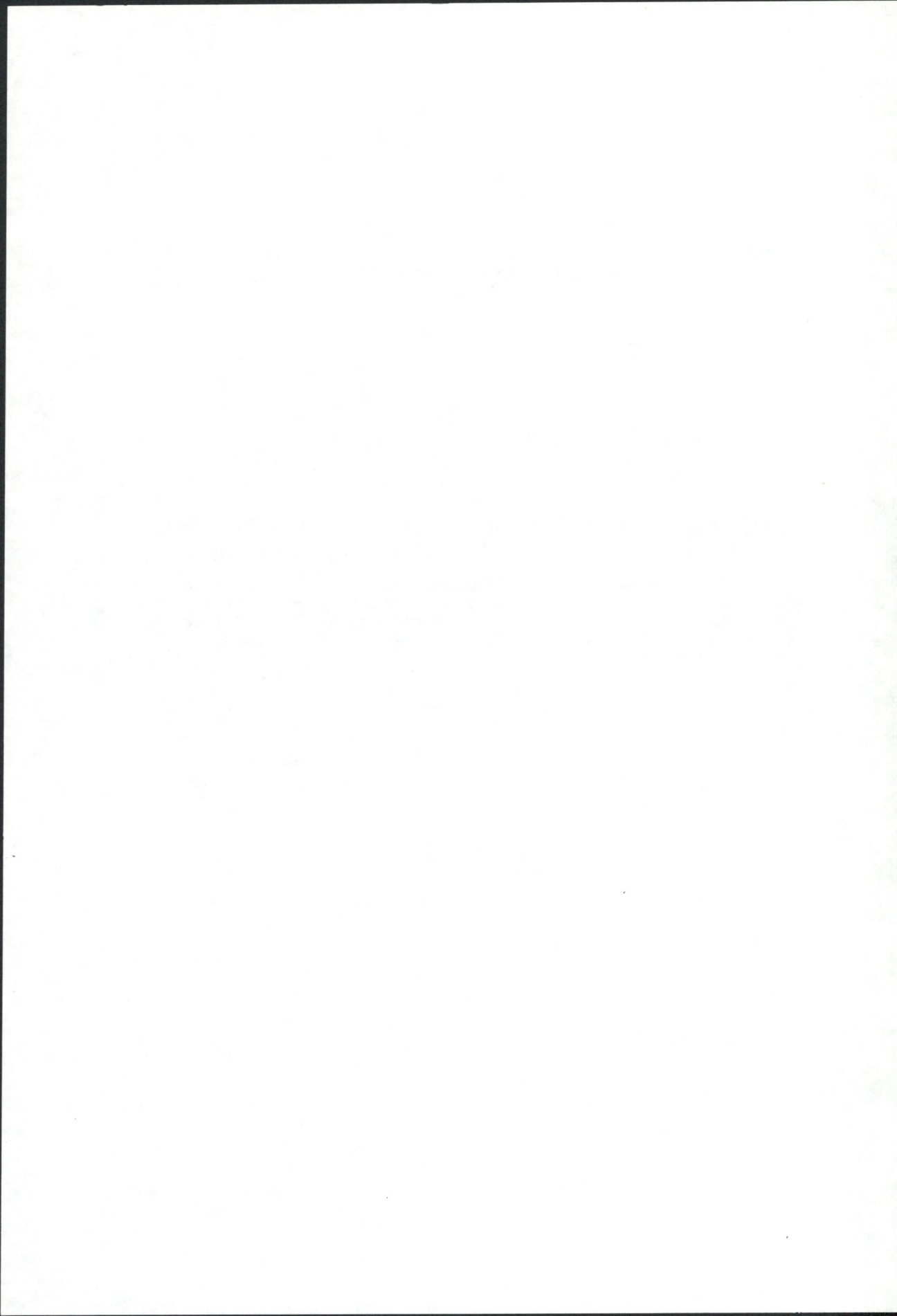


EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Prices Regulation (Amendment) Bill 1986.

The object of this Bill is to amend the Statutory and Other Offices Remuneration Act 1975 in consequence of the enactment of the proposed Prices Regulation (Amendment) Act 1986, so as to replace the reference to the Chairman of the Prices Commission with a reference to the Chairperson of the Prices Commission (being a full-time commissioner).

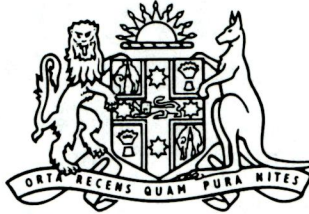

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

5 Short title

1. This Act may be cited as the "Statutory and Other Offices Remuneration (Prices Commission) Amendment Act 1986".

Commencement

2. (1) Sections 1 and 2 shall commence on the date of assent to this
10 Act.

(2) Except as provided by subsection (1), this Act shall commence on the day on which the Prices Regulation (Amendment) Act 1986 commences.

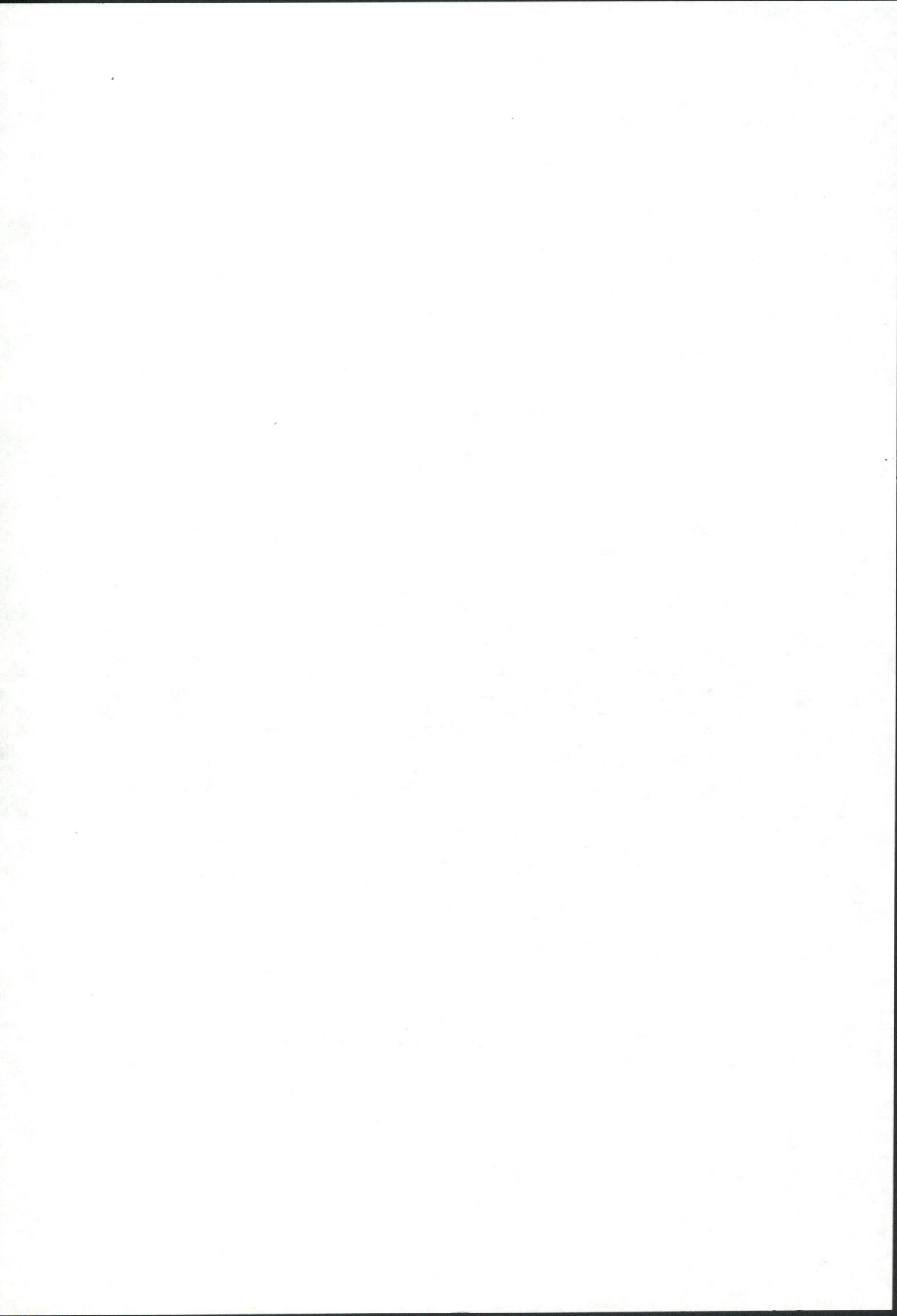

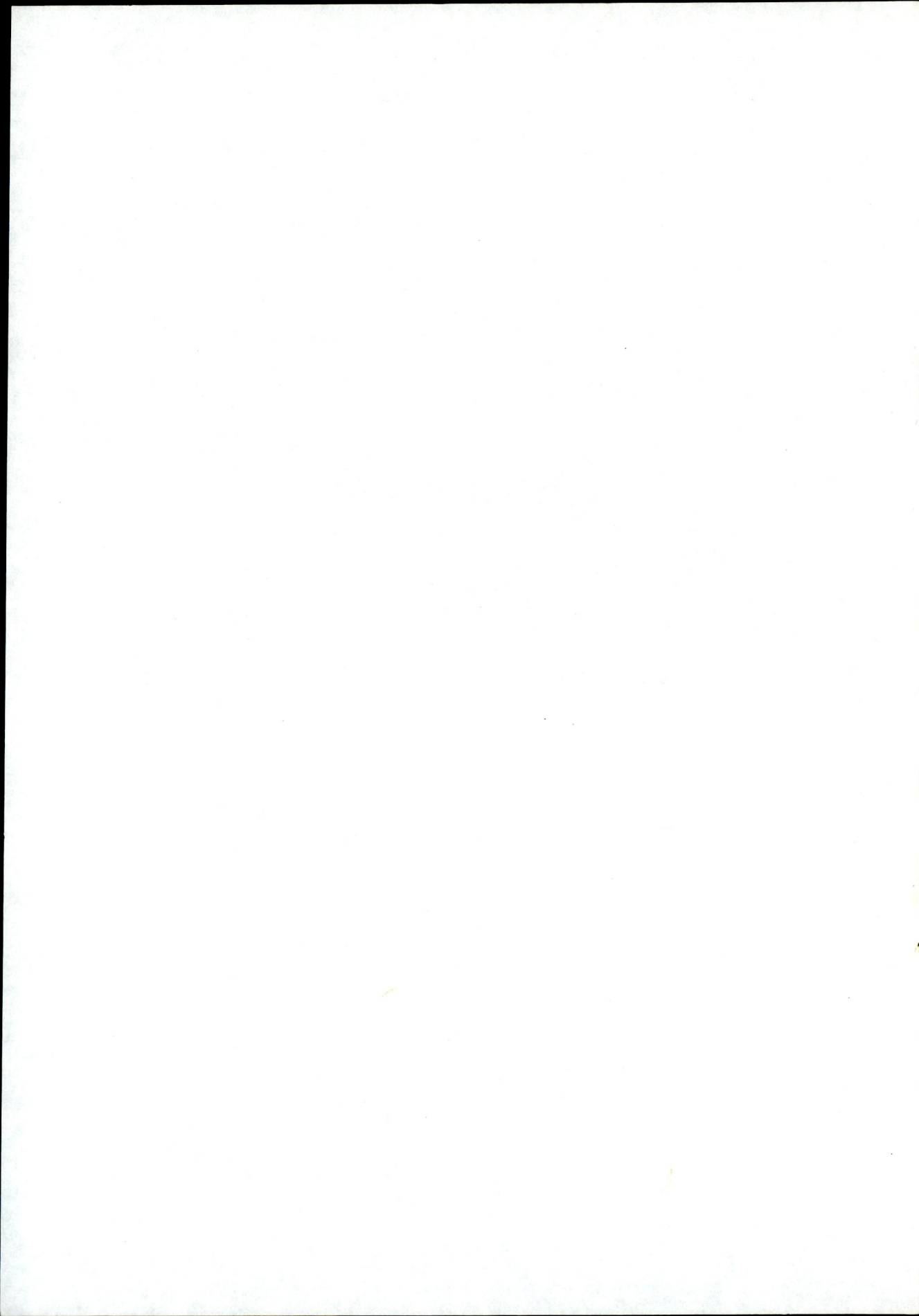

Act No. 34, 1986

An Act to amend the Statutory and Other Offices Remuneration Act 1975 consequent upon the enactment of the Prices Regulation (Amendment) Act 1986. [Assented to 6 May 1986.]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

Short title

1. This Act may be cited as the "Statutory and Other Offices Remuneration (Prices Commission) Amendment Act 1986".

Commencement

2. (1) Sections 1 and 2 shall commence on the date of assent to this Act.

(2) Except as provided by subsection (1), this Act shall commence on the day on which the Prices Regulation (Amendment) Act 1986 commences.
