EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Residential Tenancies Tribunal Bill 1986.

The object of this Bill is to amend the Statutory and Other Offices Remuneration Act 1975 to provide for the remuneration of the Chairperson and other full-time members of the proposed Residential Tenancies Tribunal.

Clause 1 specifies the short title of the proposed Act.

Clause 2 amends Schedule 2 to the Statutory and Other Offices Remuneration Act 1975 so as to make provision for the determination of the remuneration of the Chairperson and other full-time members of the Residential Tenancies Tribunal established under the proposed Residential Tenancies Tribunal Act 1986.

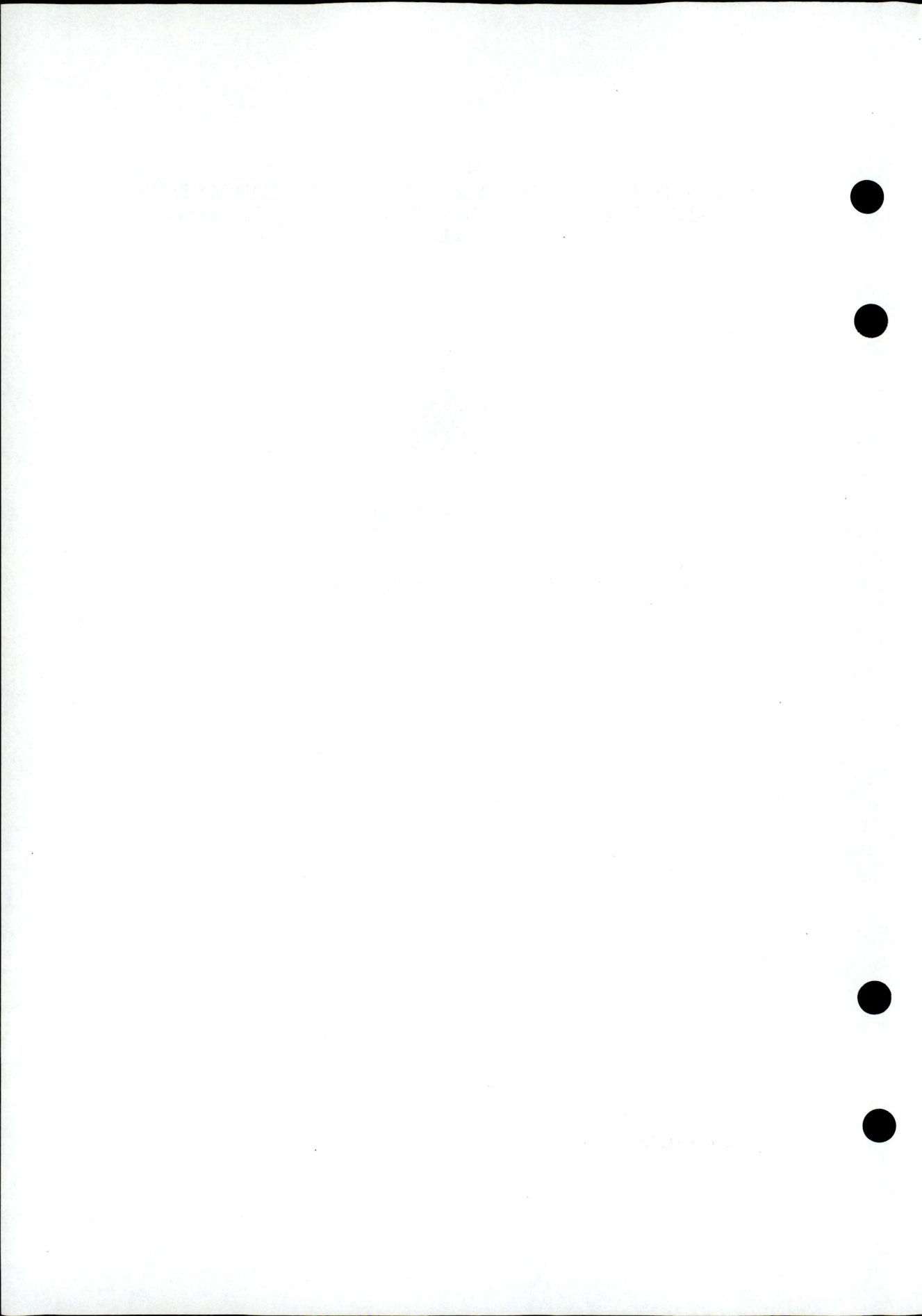

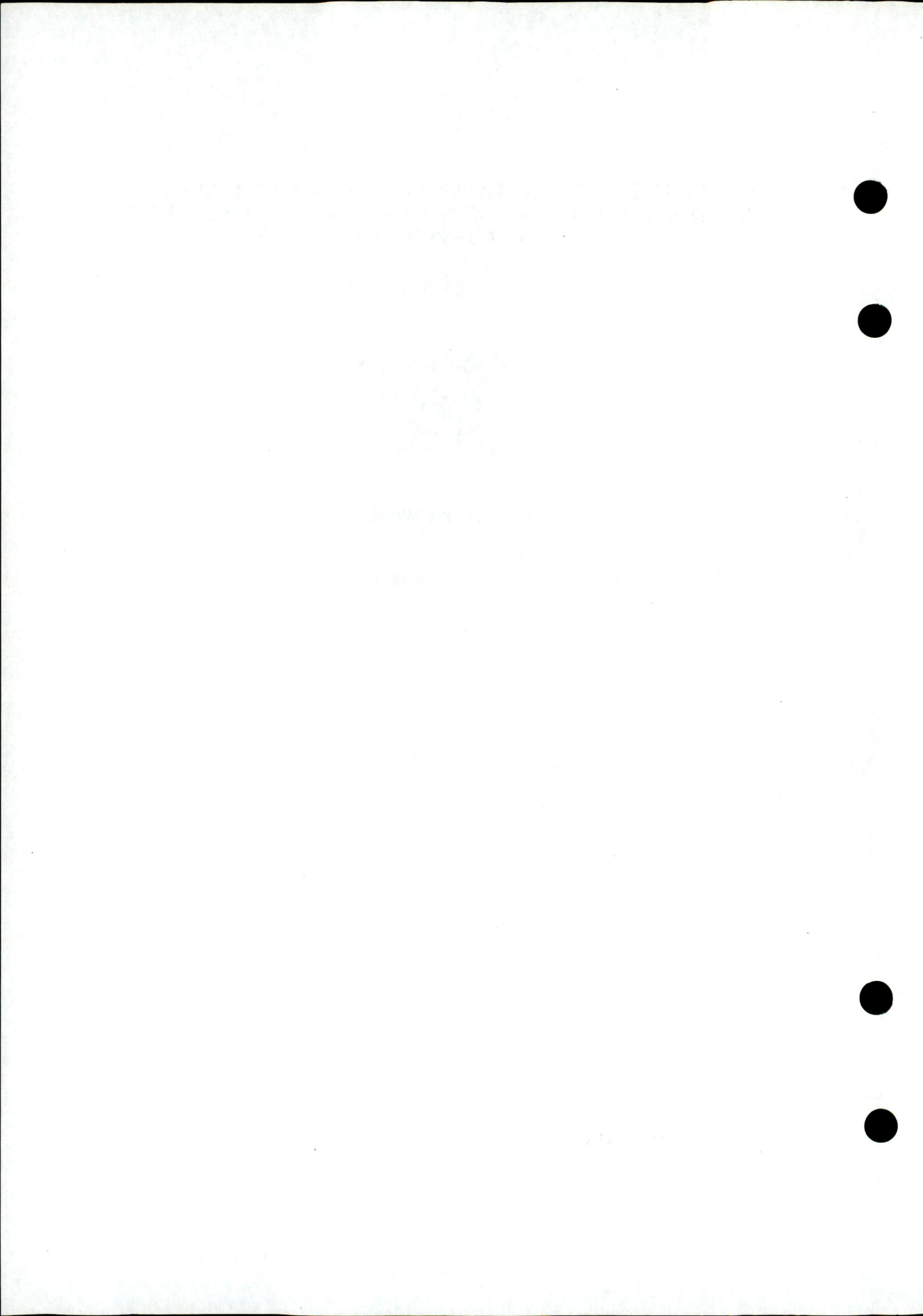
