EXPLANATORY NOTE

This Bill is cognate with the Sydney Farm Produce Market Authority (Amendment) Bill 1985.

The object of this Bill is to amend Schedule 2 to the Statutory and Other Offices Remuneration Act 1975, replacing the reference to the Chairman of the Sydney Farm Produce Market Authority with a reference to the Managing Director of the Sydney Market Authority.

Clause 1 specifies the short title of the proposed Act.

Clause 2 provides for the commencement of the proposed Act.

Clause 3 effects the amendment described above.
