SUBORDINATE LEGISLATION (REPEAL) BILL 1985

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Statute Law (Miscellaneous Provisions) Bill 1985.

The object of this Bill is to repeal certain subordinate legislation (regulations, rules, by-laws and ordinances) published in the Gazette on or before 31 January 1985.

Clause 1 specifies the short title of the proposed Act.

Clause 2 contains interpretation provisions.

Clause 3 repeals all subordinate legislation, other than that specified or described in Schedule 1, that was published in the Gazette on or before 31 January 1985.

Clause 4 authorises the Governor, by proclamation, to reverse a repeal under the proposed section 3.

Schedule 1 contains the exceptions to the subordinate legislation to be repealed by the proposed section 3.

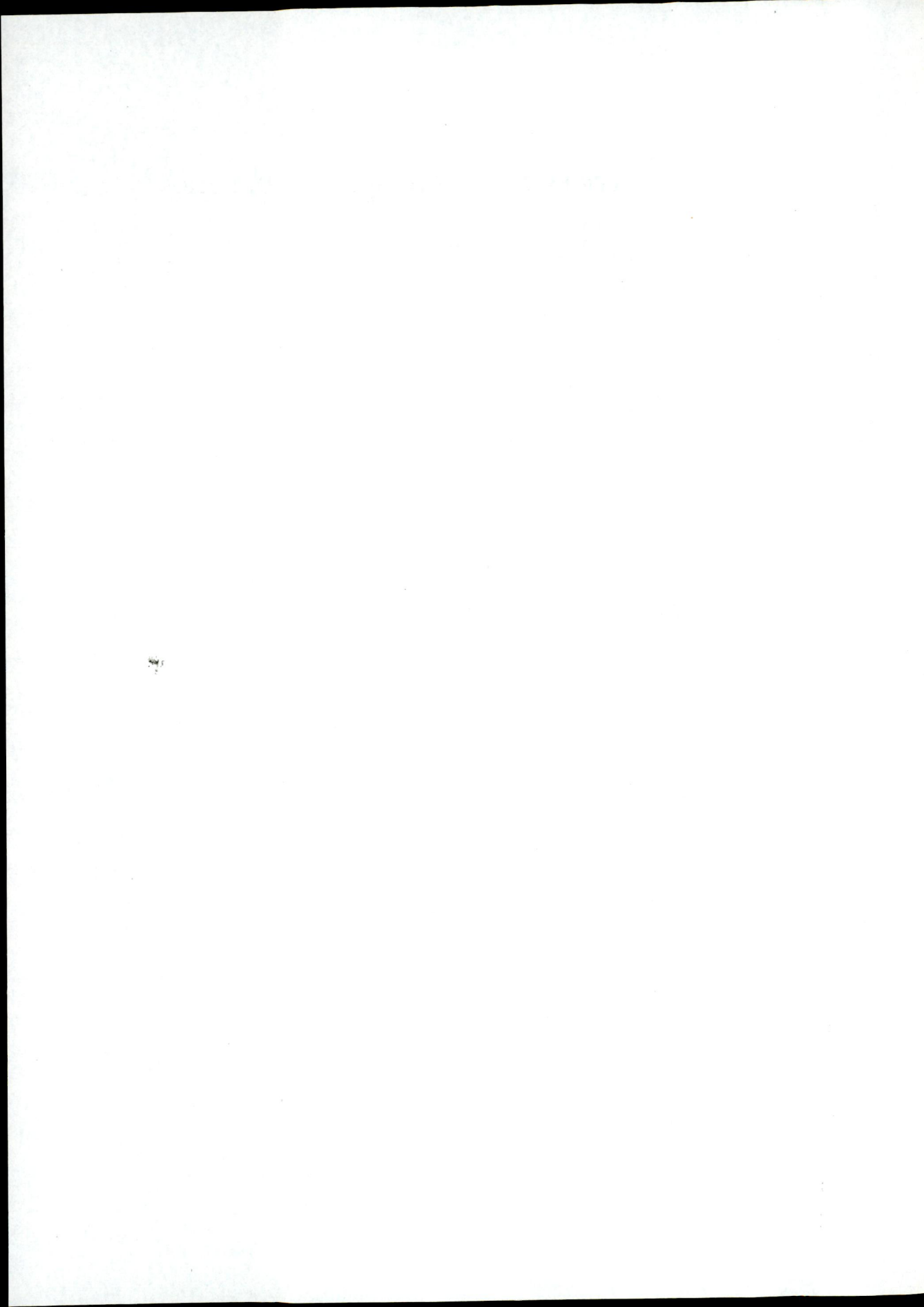

SUBORDINATE LEGISLATION (REPEAL) BILL 1985

No. , 1985

A BILL FOR

An Act to repeal certain subordinate legislation; and for other purposes.

Subordinate Legislation (Repeal) 1985

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

5 Short title

1. This Act may be cited as the "Subordinate Legislation (Repeal) Act 1985".

Interpretation

2. (1) In this Act—

10 "subordinate legislation" means a regulation, rule, by-law or ordinance that—

(a) is in force at the date of assent to this Act;

(b) was made under an Act—

(i) by the Governor; or

15 (ii) by any other person or by any body and was required by the Act under which it was made to be approved or confirmed by the Governor or submitted for the approval of the Governor; and

20 (c) was published in the Gazette in pursuance of a requirement of any Act.

(2) Where the citation, specified in Schedule 1, of any subordinate legislation has been changed before the date of assent to this Act, the citation so specified shall be read as a reference to the changed citation.

Repeal of subordinate legislation

25 **3.** All subordinate legislation (other than that specified in Part A, or described in Part B, of Schedule 1) that, in pursuance of a requirement of any Act, was published in the Gazette on or before 31 January 1985 is repealed.

Revocation of repeal

30 **4. (1)** The Governor may by proclamation published in the Gazette revoke the repeal of any subordinate legislation effected by section 3.

Subordinate Legislation (Repeal) 1985

(2) Any subordinate legislation the subject of a proclamation under subsection (1) shall be deemed not to be, and never to have been, repealed by section 3.

(3) Subsection (2) does not operate in respect of any subordinate
5 legislation so as—

- (a) to affect in a manner prejudicial to any person (other than the State or an authority of the State) the rights of that person existing before the date of publication in the Gazette of the proclamation under subsection (1) in respect of that subordinate legislation; or
- 10 (b) to impose liabilities on any person (other than the State or an authority of the State) in respect of anything done or omitted to be done before the date of publication of that proclamation.

[Assented to, 18th December, 1985.]

Subordinate Legislation (Repeal) 1985

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

Short title

1. This Act may be cited as the "Subordinate Legislation (Repeal) Act 1985".

Interpretation

2. (1) In this Act—

"subordinate legislation" means a regulation, rule, by-law or ordinance that—

- (a) is in force at the date of assent to this Act;
- (b) was made under an Act—
 - (i) by the Governor; or
 - (ii) by any other person or by any body and was required by the Act under which it was made to be approved or confirmed by the Governor or submitted for the approval of the Governor; and
- (c) was published in the Gazette in pursuance of a requirement of any Act.

(2) Where the citation, specified in Schedule 1, of any subordinate legislation has been changed before the date of assent to this Act, the citation so specified shall be read as a reference to the changed citation.

Repeal of subordinate legislation

3. All subordinate legislation (other than that specified in Part A, or described in Part B, of Schedule 1) that, in pursuance of a requirement of any Act, was published in the Gazette on or before 31 January 1985 is repealed.

Revocation of repeal

4. (1) The Governor may by proclamation published in the Gazette revoke the repeal of any subordinate legislation effected by section 3.

Subordinate Legislation (Repeal) 1985

(2) Any subordinate legislation the subject of a proclamation under subsection (1) shall be deemed not to be, and never to have been, repealed by section 3.

(3) Subsection (2) does not operate in respect of any subordinate legislation so as—

- (a) to affect in a manner prejudicial to any person (other than the State or an authority of the State) the rights of that person existing before the date of publication in the Gazette of the proclamation under subsection (1) in respect of that subordinate legislation; or
- (b) to impose liabilities on any person (other than the State or an authority of the State) in respect of anything done or omitted to be done before the date of publication of that proclamation.
