EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the State Roads Bill 1986.

The object of this Bill is to amend the Sydney Harbour Bridge (Administration) Act 1932 to substitute for references to the Commissioner for Main Roads appointed under the Transport (Division of Functions) Act 1932 references to the person holding or acting in that office under the proposed State Roads Act 1986.

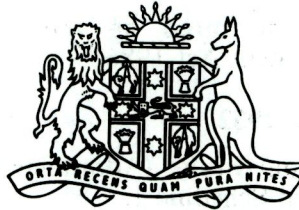

Sydney Harbour Bridge (Administration) Amendment 1986

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

Sydney Harbour Bridge (Administration) Amendment 1986

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:
