EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Bennelong Point (Parking Station) Bill 1985.

The object of this Bill is to amend the Sydney Opera House Trust Act 1961 to delete provision for the vesting in the Sydney Opera House Trust of the parking station that was proposed under the Sydney Opera House Act 1960 but not constructed.

Sydney Opera House Trust (Amendment) 1985

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

5 Short title

1. This Act may be cited as the "Sydney Opera House Trust (Amendment) Act 1985".
