#### **EXPLANATORY NOTE**

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Registered Clubs (Entertainment) Amendment Bill 1986.

The object of this Bill is to amend the Theatres and Public Halls Act 1908 to apply the provisions of that Act to certain premises registered under the Registered Clubs Act 1976.

Clause 1 specifies the short title of the proposed Act.

Clause 2 provides that the proposed Act will, with minor exceptions, commence on the day on which Schedule 1 (3) to the proposed Registered Clubs (Entertainment) Amendment Act 1986 commences.

Clause 3 amends section 3A of the Principal Act to apply the provisions of that Act to functions held on the premises of a registered club which are the subject of an authority referred to in section 23 of the Registered Clubs Act 1976 in the same way as those provisions apply to a theatre or public hall or entertainment provided in a theatre or public hall.

## A BILL FOR

An Act to amend the Theatres and Public Halls Act 1908 to provide for the application of that Act to and in respect of certain premises registered under the Registered Clubs Act 1976.

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

#### 5 Short title

1. This Act may be cited as the "Theatres and Public Halls (Registered Clubs) Amendment Act 1986".

#### Commencement

- 2. (1) Sections 1 and 2 shall commence on the date of assent to this 10 Act.
  - (2) Except as provided by subsection (1), this Act shall commence on the day on which Schedule 1 (3) to the Registered Clubs (Entertainment) Amendment Act 1986 commences.

### Amendment of Act No. 13, 1908, s. 3A (Application of Act)

- 15 3. The Theatres and Public Halls Act 1908 is amended by inserting at the end of section 3A the following subsection:
- (2) Where an authority referred to in section 23 of the Registered Clubs Act 1976 is in force in relation to the premises of a registered club within the meaning of that Act, and is subject to a condition that those premises be licensed under this Act, this Act, subject to such modifications (if any) as are specified in the authority, applies to and in respect of those premises and functions held on those premises in the same way as it applies to a theatre or public hall and public entertainment provided in a theatre or public hall and so applies whether or not those functions are public entertainment.
