# **TRAFFIC AUTHORITY (AMENDMENT) BILL 1986**

### EXPLANATORY NOTE

### (This Explanatory Note relates to this Bill as introduced into Parliament)

The object of this Bill is to amend the Traffic Authority Act 1976 to permit an increase in the membership of the Traffic Authority of New South Wales.

Clause 1 specifies the short title of the proposed Act.

Clause 2 is a formal provision which gives effect to the Schedule of amendments.

Schedule 1 (1) makes it clear that the holder of an office referred to in the Principal Act includes any person duly acting in the office.

Schedule 1 (2) provides for an overall increase of 2 in the number of members of the Traffic Authority of New South Wales as follows:

- (a) Official members are increased from 5 to 6. The new official member is the Secretary, Ministry of Transport.
- (b) Appointed members are increased from 4 to 5. The position of the member appointed by the Minister as the Minister's personal representative is abolished and 2 new positions are created, being members appointed by the Minister—
  - (i) one of whom shall represent employers within the road transport industry generally; and
  - (ii) one of whom shall represent the medical profession generally.

Schedule 1 (3) provides for the appointment of a deputy member to the member appointed by the Minister to represent the medical profession generally.

# A BILL FOR

An Act to amend the Traffic Authority Act 1976 with respect to the constitution of the Traffic Authority of New South Wales.
