**EXPLANATORY NOTE**

**(This Explanatory Note relates to this Bill as introduced into Parliament)**

This Bill is cognate with the State Roads Bill 1986.

The object of this Bill is to amend the Transport (Division of Functions) Act 1932—

- (a) to repeal provisions conferring on the Commissioner for Main Roads functions to be conferred on the Commissioner by the proposed State Roads Act 1986; and
  - (b) to repeal the provisions providing for the appointment of a Deputy Commissioner for Main Roads and for the exercise of functions by the Deputy Commissioner.
