## TRUSTEE (AMENDMENT) BILL, 1984

## **EXPLANATORY NOTE**

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Credit Union (Amendment) Bill, 1984.

The object of this Bill is to amend section 14 (4) of the Trustee Act, 1925 (which, amongst other things, prevents a trustee from purchasing at a price exceeding their redemption value any "trustee" securities which are liable to be redeemed within 15 years of the date of purchase at par or at some other fixed rate), to make it clear that paragraph (a) of that subsection does not apply to the extent that a provision of any other Act declares that that paragraph does not apply to specified securities. Schedule 2 (12) (i) to the Credit Union (Amendment) Bill, 1984, amends section 19 of the Credit Union Act, 1969, to make such a declaration.

## Trustee (Amendment) 1984

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

### 5 Short title.

1. This Act may be cited as the "Trustee (Amendment) Act, 1984".

#### Commencement.

- 2. (1) Sections 1 and 2 shall commence on the date of assent to this Act.
- (2) Except as provided by subsection (1), this Act shall commence 10 on the day on which Schedule 2 (12) (i) to the Credit Union (Amendment) Act, 1984, commences.






