## WASTE DISPOSAL (AMENDMENT) BILL 1986

NEW SOUTH WALES



### EXPLANATORY NOTE

**(This Explanatory Note relates to this Bill as introduced into Parliament)**

The object of this Bill is to enable certain conditions to be imposed—

- (a) upon licences held by transporters of waste; and
- (b) upon certificates of registration of premises at which waste is generated or which are used as waste depots.

The conditions contemplated will require certain documentation to be completed in relation to the movement of wastes from the point of collection to the point of deposition at a depot.

Clause 1 specifies the short title of the proposed Act.

Clause 2 gives effect to the Schedule of amendments.

Schedule 1 (1), (2) and (4) make amendments in consequence of the amendment made by Schedule 1(3).

Schedule 1 (3) amends section 23 (5) of the Principal Act so as to permit the imposition of the conditions described above and to express clearly the discretion of the Metropolitan Waste Disposal Authority as to the kinds of conditions it may impose upon licences and certificates.

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

**5 Short title**

**1.** This Act may be cited as the "Waste Disposal (Amendment) Act 1986".

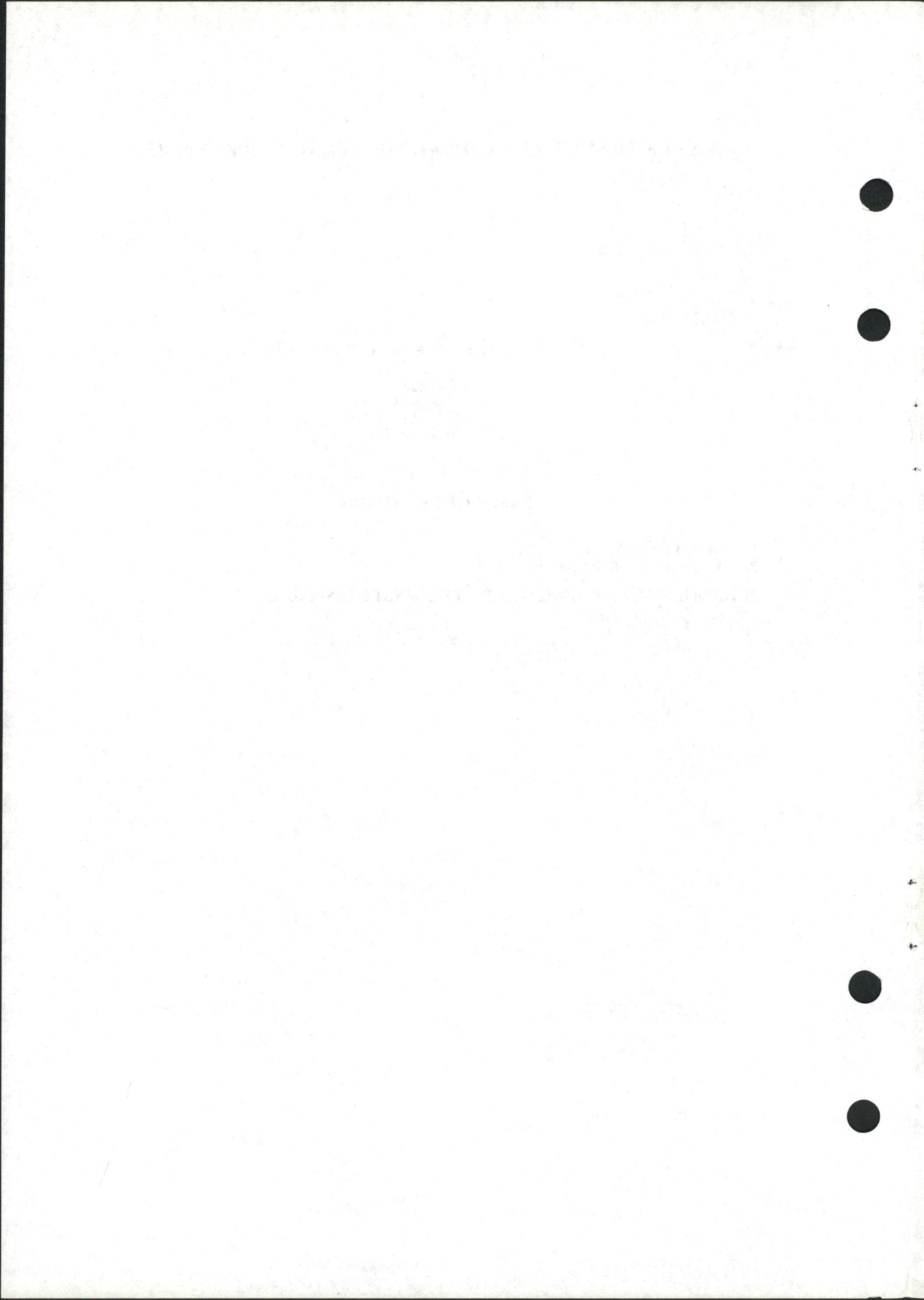
